ORDINANCE NO. 2018-O- 05

AN ORDINANCE TO APPROVE A SALE OF REAL ESTATE

WHEREAS, on May 3, 2018, the Board of Trustees of the Village of Palestine, Crawford County, Illinois, did adopt Resolution 2018-R- 01 , to authorize the sale of surplus real estate by the staff of the municipality in accordance with the provisions of the Illinois Municipal Code, being 65 ILCS 5/11-76-4.2(c); and

WHEREAS, following the adoption of said Resolution, a public advertisement for sealed bids was made for sale of said real estate, and

WHEREAS, LARRY L. DUNLAP and LISA J. DUNLAP, as joint tenants have submitted a bid for said real estate, being the sum of \$4,000.00, which the Village finds acceptable.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, as follows:

1. That the offer of LARRY L. DUNLAP and LISA J. DUNLAP in the amount of \$4,000.00 for purchase of the following described real estate, to-wit:

Forty-five (45) feet off the East side of Lot Numbered 29 in Pattons Addition to the Village of Palestine, Illinois situated in the County of Crawford, State of Illinois.

2. That the Village President and the Village Clerk, be, and they are hereby authorized to execute such instruments and take such actions as shall be reasonable and necessary to complete the sale.
