ORDINANCE NO. 2018-0- 06 TAX LEVY ORDINANCE

WHEREAS, the Board of Trustees of the Village of Palestine, Crawford County, Illinois, did on the 3rd day of May, 2018 adopt the Annual Appropriation Ordinance for said Village for the fiscal year beginning on the 1st day of May, 2017 the amount of which is ascertained to be in the aggregate the sum of \$1,079,750.00 which said Appropriation Ordinance was duly published on the 3rd day of May, 2018, and is hereby incorporated by reference.
