ORDINANCE NO. 2018 – O - 10  
AN ORDINANCE TO AMEND CHAPTER 7, SEWER SERVICE,  
SECTION 7.18, UTILITY DEPOSITS  
THE PALESTINE VILLAGE CODE

BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 7, SEWER SERVICE, SECTION 7.18, UTILITY DEPOSITS – of the Palestine Village Code, be, and the same is hereby adopted as follows:

7.18 UTILITY DEPOSITS. When any application is made for sewer utility services in accordance with the provisions of this Chapter, all applicants who are property owners,

Renters, or Lessees, of residential property, for which the service is requested, shall deposit with the application, the sum of FORTY-FIVE AND NO DOLLARS (\$45.00). The deposits made under the provisions of this Chapter shall be held by the Village of Palestine as security for the payment of sewer utilities used by the applicant upon the premises to which the application pertains and may be so applied when any default is made in the payment of the utilities bill in accordance with the Chapter. The depositor shall earn no interest. The deposit shall be refunded to the applicant upon termination of sewer utility services, provided that the charges therefore have been paid in full.

This change was approved in the Board of Trustees meeting held on December 1, 2016, and this Ordinance shall be effective retroactively, having commenced on January 1, 2017.

This Ordinance shall be in full force and effect from and after its passage, approval and Publication in pamphlet form as provided by law.


