WHEREAS, the Board of Trustees of the Village of Palestine, Crawford County, Illinois, did on the /y day of _______, 2021 adopt the Annual Appropriation Ordinance for said Village for the fiscal year beginning on the 1st day of May, 2021 the amount of which is ascertained to be in the aggregate the sum of \$ 989,500 which said Appropriation Ordinance was duly published on the /y day of _______, 2021, and is hereby incorporated by reference.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of Palestine, Crawford County, Illinois, as follows:

Section 1. That there be and is hereby levied upon all taxable property within the corporate limits of the Village of Palestine, Illinois, for general corporate purposes of said Village for the fiscal year beginning the 1st day of May, 2021, the sum of \$25,000.00 as follows:
