ORDINANCE NO. 2024-O- 08

**AN ORDINANCE TO VACATE AN ALLEY IN WABASH ADDITION  
TO THE VILLAGE OF PALESTINE, CRAWFORD COUNTY, ILLINOIS**

BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that it has determined that the public interest would be served by vacating an alley between Lot 6 B 1 on the West and Lot 1 B 10 on the East of Wabash Addition to the Village of Palestine, Illinois, and accordingly, said alley is hereby declared to be vacated; and a plat of said vacated alley is attached hereto and incorporated herein by reference as Exhibit A.

PROVIDED, HOWEVER, that the Village of Palestine, Crawford County, Illinois, retains the right to maintain, operate, repair and replace, by itself or by any licensee, or a holder or a franchise from the Village, any poles, wires, pipes, conduits, sewer mains, water mains, or any other facility or equipment for the maintenance or operation of any utility now, or in the future, located in the street, or any part thereof, vacated by this Ordinance.

BE IT FURTHER ORDAINED that the Village Clerk record in the Office of the Recorder of Crawford County, Illinois, a duly certified copy of this Ordinance.
