ORDINANCE NO. 2013- O - 01

AN ORDINANCE TO AMEND ORDINANCE NO. 2012-O-01
CHAPTER 41, TRAFFIC: SECTION 41.23
NEIGHBORHOOD VEHICLES
OF THE PALESTINE VILLAGE CODE

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois has determined that an Ordinance for the operation of Neighborhood Vehicles as defined in Illinois Compiled Statues, being 65 ILCS 5/1-148.3m should be limited to a period of **One Year**, commencing on the date of the adoption of this Ordinance and ending one year thereafter; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois has carefully researched through the National Highway Traffic Safety Administration the regulations under Title 49 C.F.R. Part 571.500, et seq., and the Illinois Vehicle Code with regard to such matters; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that this Ordinance shall only apply to matters occurring within the corporate limits of such Village; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that 4-wheelers and 3-wheelers are all-terrain vehicles designed for off-road use only and are not permitted to operate on streets, roads or highways and accordingly, are not covered by the provisions of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 41 - TRAFFIC, is hereby amended to add Section 41.23, Neighborhood Vehicles, as follows:

41.23 NEIGHBORHOOD VEHICLES

The purpose of this ordinance is to protect, maintain, and enhance health, safety and general welfare of the citizens of the Village of Palestine. It has come to the attention of the Village President and the Board of

Trustees that the use of Neighborhood Vehicles on city streets creates a potential traffic hazard for other vehicular traffic as well as a danger to the occupants of Neighborhood Vehicles. After consideration of the volume, speed and character of traffic on the Village streets, the Village Board has determined that Neighborhood Vehicles may safely travel on Village Streets.

Therefore, the intent of the Ordinance is to regulate the use of Neighborhood Vehicles within the corporate limits of the Village of Palestine as authorized by Illinois Compiled Statutes, being 625 ILCS 5/11-1426.1 (3), OPERATION OF NON-HIGHWAY VEHICLES ON STREETS, ROADS, AND HIGHWAYS.

A: Definitions

1. Neighborhood Vehicles - (625 ILCS 5/1-148.3m)

A self-propelled electric powered, four-wheeled motor vehicle (or a self-propelled, gasoline powered, four-wheeled motor vehicle with an engine displacement under 1,200 cubic centimeters) that is capable of operating at maximum speed of no more than 25 miles per hour, and which conforms to Federal Regulations under Title 49 C.F.R. Part 571.500. This specifically excludes 3 and/or 4 wheel All Terrain vehicles which are designed for off-road only.

2. "Village Street" means any of the streets (as designated on the attached map) within the boundaries of the Village of Palestine, except for State and County roads.

3. "State Roads" include Illinois Route 33.

4. "County Roads" include any roads outside the boundaries of the Village Limits of Palestine.

5. "Resident" - a person who has a bona-fide address and lives within the boundaries of the Village Limits of Palestine.

B: Requirements

All persons wishing to operate a Neighborhood Vehicle on the streets of Palestine must insure compliance with the following requirements:

1. Must be a resident of the Village of Palestine, Illinois, living within the boundaries of the Village Limits.

2. Must be 21 years of age or older.

3. Must have a valid Driver's License.

4. Must have Proof of Liability insurance on said vehicle.

5. Must be inspected by Village Police Chief or designated representative.

6. Must be equipped with seatbelts, a full windshield, horn, brakes, turn signals, a steering wheel apparatus, a rearview mirror, red reflective warning devices in the front and rear, a slow moving vehicle emblem (as required of other vehicles in 625 ILCS 5/12-709) on the rear of the vehicle, a headlight that emits a white light that is visible from a distance of 500 feet to the front, a tail lamp that emits a red light visible from at least 100 feet from the rear of the vehicle, and brake lights.

7. When operated on a roadway, a Neighborhood Vehicle shall have its headlight and tail lamps lighted.

8. Maximum speed must not exceed 25 miles per hour.

9. Must have title to vehicle.

10. No modification of Neighborhood Vehicle suspension

11. Must display Palestine Neighborhood Vehicle Permit.

12. Must obey all Traffic Laws of the State of Illinois and the Village of Palestine.

13. May only operate on Village Streets as designated on the map issued with Golf Card and Neighborhood Vehicle permits, and on County and LaMotte Township Roads to and from Palestine Cemetery and Leaverton Park, as designated on same map.

14. May not operate on any portion of Illinois State Route 33 (Washington, Franklin and Jackson Streets).

15. May cross Route 33 only at intersections designated on above map. These crossings are not approved (at this time) by the State of Illinois Department of Transportation.

16. Neighborhood Vehicles may only be operated on designated Village Streets (clearly shown on operator's map) from sunrise to sunset.

17. Neighborhood Vehicles shall not be operated in inclement weather, nor when visibility is impaired by weather, smoke, fog, or other conditions, or at any time there is insufficient light to clearly see persons and vehicles on the roadway at a distance of 500 feet.

18. A person who drives or is in physical control of a Neighborhood Vehicle, on a roadway, while under the influence of alcohol and/or drugs (whether prescription or non-prescription; legal or illegal) is subject to Section 11-500 through 11-502 of the Illinois Compiled Statutes (625 ILCS 5/11-500 through 11-502).

19. Neighborhood Vehicles may not be operated on sidewalks or other public property not accessible to/or authorized to vehicular traffic.

20. Neighborhood Vehicles may not be operated on streets, highways, and roads under the jurisdiction of the Illinois Department of Transportation (Illinois Route 33) or the County Highway Department, but may be operated on County Roads and Township Roads to Palestine cemetery and Leaverton Park. This per written agreement with Crawford County Board, LaMotte Township Board, and Crawford County Sheriff.

C. Permits

1. No person shall operate a motorized Neighborhood Vehicle in the Village of Palestine without first obtaining a permit from the Village Clerk as provided herein. Permits shall be granted for a period of one (1) year and may be renewed annually. The cost of a permit is \$35.00 per year. Insurance coverage is to be verified to be in effect by the Palestine Village Clerk when obtaining and renewing a permit.

2. Every application for a permit shall be made on a form supplied by the Palestine Village Clerk and shall contain the following information:

a. Name, address and phone number of applicant

- b. Name of Liability Insurance Carrier
- c. Serial Number, make, model and description with photo of the Neighborhood Vehicle
- d. Photocopy of title and applicable liability insurance card specifically for the Neighborhood Vehicle to be operated on Village Streets.
- e. Signed General Release of Liability, Waiver, Discharges any covenant, not to sue by applicant, releasing the Village of Palestine, the County of Crawford, the Township of LaMotte and all other governmental entities which have approved the operation of Neighborhood Vehicles on their roadways of and from all liability for direct, indirect, special, incidental or consequential damages, whether arising in court, contract or any other legal theories, in connection with or arising out of the operator's use of a Neighborhood Vehicle, and, in addition, this operator shall save, hold harmless and indemnify such governmental entities against any and all liability, claims, causes of action and costs of whatsoever kind and nature, including, without being limited to injury, damage, loss including death, resulting from, arising out of, occurring in connection with the use of a Neighborhood Vehicle pursuant to this ordinance or any other ordinance of the Village of Palestine.
- f. Such other information as the Village may require.

3. No permit shall be granted unless the following conditions are met:

- a. The Neighborhood Vehicle must be inspected by the Village Chief of Police (or designee) to insure that the vehicle is safe to operate on Village Streets and is in compliance with this ordinance.
- b. The handicapped applicant must submit a certificate signed by a physician, that the handicapped applicant is able to safely operate a motorized Neighborhood Vehicle on the streets and roadways designated.
- c. The applicant must provide evidence of insurance in compliance within the provisions of the Illinois Statutes regarding minimum liability insurance for passenger motor vehicles to be operated on the roads of the State of Illinois.

The Village Board of Trustees for the Village of Palestine, Illinois, may suspend or revoke a permit granted hereunder upon as finding that the holder thereof has violated any of the provisions of this ordinance or if there is evidence that the permittee cannot safely operate the motorized Neighborhood Vehicle on the designated roadways.

Every person operating a Neighborhood Vehicle pursuant to permit hereunder on designated Village Streets have all the rights and duties applicable to a drive of any other vehicle pursuant to the State Highway Traffic Laws and Regulations except when those provisions cannot reasonably be applied to motorized Neighborhood Vehicles.

Any person who violates any provision of this ordinance shall upon conviction be subject to a fine of not less than \$55.00 nor more than \$750.00 and the costs of prosecution. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



2. All illegal gambling devices and slot machines, and specifically allows legal gaming.



Section 8: A statement that applicant will not allow illegal gambling devices on the premises, and specifically allows legal gaming.



This is with the exception of **CASEY'S GENERAL STORE**, for which the Board of Trustees has approved new hours to keep their place of business open **to 24 hours/7 days per week, with extended hours to be open for Beer, Wine, and Malt Beverage sales, from 6:00 a.m. until 2:00 a.m.**, at which time the licensee must close their Beer, Wine, and Malt Beverage sales, and also according to their specific license. **This is in addition to the approval by the Board of Trustees to sell alcohol on Sunday, from 12:00 Noon until 6:00 p.m. (Ordinance No. 2012-O-10, approved and dated on July 5, 2012).**

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.





BE IT FURTHER ORDAINED that the said several sums of money are hereby appropriated from the monies received, and to be received, by the Village of Palestine, Illinois, from all sources.

BE IT FURTHER ORDAINED that this Ordinance shall take effect and be in force from and after its passage, approval and publication as required by law.

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workmen employed in any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, Illinois Compiled Statutes 820 ILCS 130/1 through 130/12.

WHEREAS, the aforesaid Act requires that the Village of Palestine investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workmen in the locality of said Village employed in performing construction of public works for said Village.

NOW, THEREFORE, BE IT ORDAINED by the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. To the extent and as required by "An Act regulating wages of laborers, mechanics and other workmen employed in any public works by the State, County, City or any public body or any political subdivision, or by anyone under contract for public work", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Village of Palestine is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Crawford County area as determined by the Department of Labor of the State of Illinois as of July 2013, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the aforesaid Act.

Section 3. The Village Clerk shall publicly post or keep available for inspection by any interested party in the Village of Palestine, Village Hall, Palestine, Illinois, this determination of such prevailing rate of wage.

Section 4. The Village Clerk shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.





TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Drivers on 2 axle trucks hauling less than 9 ton. Air compressor and welding machines and brooms, including those pulled by separate units, truck driver helpers, warehouse employees, mechanic helpers, greasers and tiremen, pickup trucks when hauling materials, tools, or workers to and from and on-the-job site, and fork lifts up to 6,000 lb. capacity.

Class 2. Two or three axle trucks hauling more than 9 ton but hauling less than 16 ton. A-frame winch trucks, hydrolift trucks, vector trucks or similar equipment when used for transportation purposes. Fork lifts over 6,000 lb. capacity, winch trucks, four axle combination units, and ticket writers.

Class 3. Two, three or four axle trucks hauling 16 ton or more. Drivers on water pulls, articulated dump trucks, mechanics and working forepersons, and dispatchers. Five axle or more combination units.

Class 4. Low Boy and Oil Distributors.

Class 5. Drivers who require special protective clothing while employed on hazardous waste work.

TRUCK DRIVER - OIL AND CHIP RESEALING ONLY.

This shall encompass laborers, workers and mechanics who drive contractor or subcontractor owned, leased, or hired pickup, dump, service, or oil distributor trucks. The work includes transporting materials and equipment (including but not limited to, oils, aggregate supplies, parts, machinery and tools) to or from the job site; distributing oil or liquid asphalt and aggregate; stock piling material when in connection with the actual oil and chip contract. The Truck Driver (Oil & Chip Resealing) wage classification does not include supplier delivered materials.

OPERATING ENGINEERS - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Power Cranes, Draglines, Derricks, Shovels, Gradalls, Mechanics, Tractor Highlift, Tournadozer, Concrete Mixers with Skip, Tournamixer, Two Drum Machine, One Drum Hoist with Tower or Boom, Cableways, Tower Machines, Motor Patrol, Boom Tractor, Boom or Winch Truck, Winch or Hydraulic Boom Truck, Truck Crane, Tournapull, Tractor Operating Scoops, Bulldozer, Push Tractor, Asphalt Planer, Finishing Machine on Asphalt, Large Rollers on Earth, Rollers on Asphalt Mix, Ross Carrier or similar Machine, Gravel Processing Machine, Asphalt Plant Engineer, Paver Operator, Dredging Equipment, or Dredge Engineer, or Dredge Operator, Central Mix Plant Engineer, CMI or similar type machine, Concrete Pump, Truck or Skid Mounted, Tower Crane, Engineer or Rock Crusher Plant, Concrete Plant Engineer, Ditching Machine with dual attachment, Tractor Mounted Loaders, Cherry Picker, Hydro Crane, Standard or Dinkey Locomotives, Scoopmobiles, Euclid Loader, Soil Cement Machine, Back Filler, Elevating Machine, Power Blade, Drilling Machine, including Well Testing, Caissons, Shaft or any similar type drilling machines, Motor Driven Paint Machine, Pipe Cleaning Machine, Pipe Wrapping Machine, Pipe Bending Machine, Apsco Paver, Boring Machine, (Head Equipment Greaser), Barber-Greene Loaders, Formless Paver, (Well Point System), Concrete Spreader, Hydra Ax, Span Saw, Marine Scoops, Brush Mulcher, Brush Burner, Mesh Placer, Tree Mover, Helicopter Crew (3), Piledriver-Skid or Crawler, Stump Remover, Root Rake, Tug Boat Operator, Refrigerating Machine, Freezing Operator, Chair Cart-

Class 2. Concrete Mixers without Skips, Rock Crusher, Ditching Machine under 6', Curbing Machine, One Drum Machines without Tower or Boom, Air Tugger, Self-Propelled Concrete Saw, Machine Mounted Post Hole Digger, two to four Generators, Water Pumps or Welding Machines, within 400 feet, Air Compressor 600 cu. ft. and under, Rollers on Aggregate and Seal Coat Surfaces, Fork Lift (when used for landscaping work), Concrete and Blacktop Curb Machine, One Water Pump, Oilers, Air Valves or Steam Valves, One Welding Machine, Truck Jack, Mud Jack, Gunnite Machine, House Elevators when used for hoisting material, Engine Tenders, Fireman, Wagon Drill, Flex Plane, Conveyor, Siphons and Pulsometer, Switchman, Fireman on Paint Pots, Fireman on Asphalt Plants, Distributor Operator on Trucks, Tampers, Self-Propelled Power Broom, Striping Machine (motor driven), Form Tamper, Bulk Cement Plant, Equipment Greaser, Deck Hands, Truck Crane Oiler-Driver, Cement Blimps, Form Grader, Temporary Heat, Throttle Valve, Super Sucker (and similar type of equipment).

Other Classifications of Work:

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are available. If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.



41.17 BICYCLES AND MOTORCYCLES

(e) Riding on Sidewalk Prohibited. It shall be unlawful for any person to ride a bicycle or scooter on the sidewalks adjacent to Main Street from Franklin Street to LaMotte Street.

Any person violating any provision of this Ordinance shall, upon conviction, be subject to a fine of not less than \$50.00 nor than \$750.00 and the costs of prosecution.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.







AN ORDINANCE TO AMEND CHAPTER 5 STREETS, ALLEYS
AND SIDEWALKS, SECTION 5.19 LIMITATION ON USE
OF ALLEYS OF THE PALESTINE VILLAGE CODE

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has the power and authority to regulate the use of streets, alleys and sidewalks; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that certain provisions with regard to the limitations on the use of alleys within the Palestine Village Code should be amended.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois that CHAPTER 5, STREETS, ALLEYS AND SIDEWALKS, Section 5.19 LIMITATION ON USE OF ALLEYS, be, and the same is hereby amended to be in its entirety as follows:

5.19 LIMITATION ON USE OF ALLEYS. Use of alleys shall be limited to service to and for access to adjoining properties and shall not be used as a thoroughfare by motorists in lieu of traveling on paved roadways. Emergency and public utility vehicles are exempt from this limitation. Use of an alley for access to a property adjacent thereto shall be limited to entering and existing at the nearest public street. Property owners whose property adjoins an alley shall have the right-of-way to said alley for the purpose of maintaining such property. No vehicle traveling on an alley shall exceed a speed of 15 miles per hour.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
