ORDINANCE NO. 2012-0-01

AN ORDINANCE TO AMEND CHAPTER 41,
TRAFFIC TO ADD SECTION 41.23 NEIGHBORHOOD
VEHICLES OF THE PALESTINE VILLAGE CODE

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois has determined that an Ordinance for the operation of Neighborhood Vehicles as defined in Illinois Compiled Statutes, being 65 ILCS 5/1-148.3m should be limited to a trial period of one year commencing on the date of the adoption of this Ordinance and ending one year thereafter; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois has carefully researched through the National Highway Traffic Safety Administration the regulations under Title 49 C.F.R. Part 571.500, et seq., and the Illinois Vehicle Code with regard to such matters; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that this Ordinance shall only apply to matters occurring within the corporate limits of such Village; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that 4-wheelers and 3-wheelers are all-terrain vehicles designed for off-road use only and are not permitted to operate on streets, roads or highways and accordingly, are not covered by the provisions of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 41 - TRAFFIC, is hereby amended to add Section 41.23, Neighborhood Vehicles, as follows:

41.23 NEIGHBORHOOD VEHICLES

The purpose of this ordinance is to protect, maintain, and enhance health, safety and general welfare of the citizens of the Village of Palestine. It has come to the attention of the Village President and the Board of Trustees that the use of Neighborhood Vehicles on city streets creates a potential traffic hazard for other vehicular traffic as well as a danger to the occupants of Neighborhood Vehicles. After consideration of the volume, speed and character of traffic on the Village streets, the Village Board has determined that Neighborhood Vehicles may safely travel on Village Streets.

Therefore, the intent of the Ordinance is to regulate the use of Neighborhood Vehicles within the corporate limits of the Village of Palestine as authorized by Illinois Compiled Statutes, being 625 ILCS 5/11-1426.1 (3), OPERATION OF NON-HIGHWAY VEHICLES ON STREETS, ROADS, AND HIGHWAYS.

A: Definitions

1. Neighborhood Vehicles - (625 ILCS 5/1-148.3m)

A self-propelled electric powered, four-wheeled motor vehicle (or a self-propelled, gasoline powered, four-wheeled motor vehicle with an engine displacement under 1,200 cubic centimeters) that is capable of operating at maximum speed of no more than 25 miles per hour, and which conforms to Federal Regulations under Title 49 C.F.R. Part 571.500. This specifically excludes 3-wheel and 4-wheel all terrain vehicles which are designed for off-road only, except municipally owned service vehicles.

2. "Village Street" means any of the streets (as designated on the attached map) within the boundaries of the Village of Palestine, except for State and County roads.

3. "State Roads" include Illinois Route 33.

4. "County Roads" include any roads outside the boundaries of the Village Limits of Palestine.

B: Requirements

All persons wishing to operate a Neighborhood Vehicle on the streets of Palestine must ensure compliance with the following requirements:

1. Must be 21 years of age or older.
2. Must have a valid Driver's License.
3. Must have Proof of Liability insurance on said vehicle.
4. Must be inspected by Village Police Chief or designated representative.
5. Must be equipped with seatbelts, a full windshield, horn, brakes, turn signals, a steering wheel apparatus, a rearview mirror, red reflective warning devices in the front and rear, a slow moving vehicle emblem (as required of other vehicles in 625 ILCS 5/12-709) on the rear of the vehicle, a headlight that emits a white light that is visible from a distance of 500 feet to the front, a tail lamp that emits a red light visible from at least 100 feet from the rear of the vehicle, and brake lights.
6. When operated on a roadway, a Neighborhood Vehicle shall have its headlight and tail lamps lighted.
7. Maximum speed must not exceed 25 miles per hour.
8. No modification of Neighborhood Vehicle suspension

9. Must display Palestine Neighborhood Vehicle Permit.

10. Must obey all Traffic Laws of the State of Illinois and the Village of Palestine.

11. May only operate on Village Streets as designated on the map issued with Golf Cart and Neighborhood Vehicle permits, and on County and LaMotte Township Roads to and from Palestine Cemetery and Leaverton Park, as designated on same map.

12. May not operate on any portion of Illinois State Route 33 (Washington, Franklin and Jackson Streets).

13. May cross Route 33 only at intersections designated on above map. These crossings are not approved (at this time) by the State of Illinois Department of Transportation.

14. Neighborhood Vehicles may only be operated on designated Village Streets (clearly shown on operator's map) from sunrise to sunset.

15. Neighborhood Vehicles shall not be operated in inclement weather, nor when visibility is impaired by weather, smoke, fog, or other conditions, or at any time there is insufficient light to clearly see persons and vehicles on the roadway at a distance of 500 feet.

16. A person who drives or is in physical control of a Neighborhood Vehicle, on a roadway, while under the influence of alcohol and/or drugs (whether prescription or non-prescription; legal or illegal) is subject to Section 11-500 through 11-502 of the Illinois Compiled Statutes (625 ILCS 5/11-500 through 11-502).

17. Neighborhood Vehicles may not be operated on sidewalks or other public property not accessible to/or authorized to vehicular traffic.

19. Neighborhood Vehicles may not be operated on streets, highways, and roads under the jurisdiction of the Illinois Department of Transportation (Illinois Route 33) or the County Highway Department, but may be operated on County Roads and Township Roads to Palestine cemetery and Leaverton Park. This per written agreement with Crawford County Board, LaMotte Township Board, and Crawford County Sheriff.

C: Permits

1. No person shall operate a motorized Neighborhood Vehicle in the Village of Palestine without first obtaining a permit from the Village Clerk as provided herein. Permits shall be granted for a period of one (1) year and may be renewed annually. The cost of the initial inspection including the permit will be \$75.00; the cost of an annual permit, thereafter, is \$50.00 per year. Insurance coverage is to be verified to be in effect by the Palestine Village Clerk when obtaining and renewing a permit.

2. Every application for a permit shall be made on a form supplied by the Palestine Village Clerk and shall contain the following information:

- a. Name, address and phone number of applicant
- b. Name of Liability Insurance Carrier
- c. Serial Number, make, model and description with photo of the Neighborhood Vehicle
- d. Photocopy of title and applicable liability insurance card specifically for the Neighborhood Vehicle to be operated on Village Streets.
- e. Signed General Release of Liability, Waiver, Discharges any covenant, not to sue by applicant, releasing the Village of Palestine, the County of Crawford, the Township of LaMotte and all other governmental entities which have approved the

operation of Neighborhood Vehicles on their roadways of and from all liability for direct, indirect, special, incidental or consequential damages, whether arising in court, contract or any other legal theories, in connection with or arising out of the operator's use of a Neighborhood Vehicle, and, in addition, this operator shall save, hold harmless and indemnify such governmental entities against any and all liability, claims, causes of action and costs of whatsoever kind and nature, including, without being limited to injury, damage, loss including death, resulting from, arising out of, occurring in connection with the use of a Neighborhood Vehicle pursuant to this ordinance or any other ordinance of the Village of Palestine.

f. Such other information as the Village may require.

3. No permit shall be granted unless the following conditions are met:

a. The Neighborhood Vehicle must be inspected by the Village Chief of Police (or designee) to ensure that the vehicle is safe to operate on Village Streets and is in compliance with this Ordinance.

b. The handicapped applicant must submit a certificate signed by a physician, that the handicapped applicant is able to safely operate a motorized Neighborhood Vehicle on the streets and roadways designated.

c. The applicant must provide evidence of insurance in compliance within the provisions of the Illinois Statutes regarding minimum liability insurance for passenger motor vehicles to be operated on the roads of the State of Illinois.

The Village Board of Trustees for the Village of Palestine, Illinois, may suspend or revoke a permit granted hereunder upon a finding that the holder thereof has violated any of

the provisions of this Ordinance or if there is evidence that the permittee cannot safely operate the motorized Neighborhood Vehicle on the designated roadways.

Every person operating a Neighborhood Vehicle pursuant to permit hereunder on designated Village Streets shall have all the rights and duties applicable to a driver of any other vehicle pursuant to the State Highway Traffic Laws and Regulations except when those provisions cannot reasonably be applied to motorized Neighborhood Vehicles.

Any person who violates any provision of this Ordinance shall upon conviction be subject to a fine of not less than \$55.00 nor more than \$750.00 and the costs of prosecution.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law, and shall become null and void and of no further force and effect one calendar year from the date of its passage.

AN ORDINANCE TO AMEND ORDINANCE NO. 2006-0-01
AMENDING SECTION 13: AGE RESTRICTIONS AND INSPECTION REQUIREMENTS

SECTION 13: AGE RESTRICTIONS AND INSPECTION REQUIREMENTS.

This Section 13 will remain the same, except for the following addition:


In regard to the age of Mobile Homes, the Ordinance now reads: Mobile Homes more than Ten (10) years old shall not be placed in the Village of Palestine effective as of the date of this Ordinance (January 5, 2006). Mobile Homes presently within Palestine that are over Ten (10) years of age shall be permitted to remain at their present location. Mobile Homes more than Ten (10) years of age shall not be moved from one location of Palestine to another location within Palestine, effective as of the date of this revised/amended Ordinance.

In consideration of the Ten (10) year strict policy on manufactured homes, as of the date of this amended Ordinance, it will now be at the discretion of the Board of Trustees, on a case by case petition, whether or not to issue a variance based on the age, condition, and location of each manufactured home.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



ORDINANCE NO. 2012 -0-0 4

AN ORDINANCE TO AMEND CHAPTER 34
OF THE VILLAGE OF PALESTINE CODE
AMENDING 34.06: CLASSES OF LICENSES; FEES.
WITHIN THE VILLAGE OF PALESTINE, ILLINOIS

WHEREAS, the Board of Trustees of Palestine, Illinois, has the power to regulate the Code pertaining to the Classes and Fees for Liquor establishments, pursuant to Illinois Compiled Statutes, Chapter 235, Article I, as amended from time to time.

WHEREAS, the Board of Trustees of Palestine, Illinois, has determined certain regulations regarding the Palestine Village Code are necessary and proper for the welfare of the Village and its inhabitants.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of Palestine, Crawford County, Illinois, as follows:

34.06 CLASSES OF LICENSES; FEES. Classification of an fee for retailer's licenses issued under this chapter shall be amended as follows:

CLASS A License which authorizes the retail sale on the premises of alcoholic liquor, either by the drink or in the original package. The annual fee for such license is \$1250.00 There shall be no more than two Class A License in effect in the Village at one time.

CLASS B License which authorizes the retail sale on the premises of beer or wine. The fee for such license is \$500.00 per year. There shall be no more than two Class B Licenses in effect for the Village at one time.

CLASS C License which authorizes the retail sale in the original package only of all beer, and malt beverages not for the consumption on the premises. The fee for such license is \$500.00 per year. There shall be no more than one Class C License in effect in the Village at one time.


CLASS D License which authorizes the retail sale on the premises specifically therein of alcoholic beverages to be served from the bottle or container, by the drink, for consumption on the premises, to the members of the licensee only, and their bona fide guests, who shall accompany them, and may be issued only to regularly constituted units of the American Legion, Veteran of Foreign Wars, Fraternal Order of the Eagles, Fraternal Order of the AMVETS, Country Club, and other orders and clubs of nationwide membership who maintain club rooms; annual fee for such license shall be \$850.00. There shall be no more than two Class D License in effect in the Village at one time.

WINERY LICENSE as provided in Section 34.33 hereof.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



ADDING 34.08A: EXTENSION OF DURATION OF LICENSES

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of Palestine, Crawford County, Illinois, as follows:

34.08A EXTENSION OF DURATION OF LICENSES Upon application for a BEER GARDEN PERMIT, complete with overview of the proposed Beer Garden, a review will be made by the LOCAL LIQUOR CONTROL COMMISSIONER, on a case by case basis, including inspection of designated premises/site, etc. Once approval of said application, a BEER GARDEN PERMIT will be issued by the LOCAL LIQUOR CONTROL COMMISSIONER. A one time fee for BEER GARDEN PERMIT for a one-day event, will be \$20.00. A BEER GARDEN SUMMER PERMIT is one defined with a duration from June 1 through the October, not to extend beyond November 1 of each year. The annual fee for a BEER GARDEN SUMMER PERMIT will be \$150.00.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



AN ORDINANCE TO ESTABLISH THE PREVAILING RATE
OF WAGES WITHIN THE VILLAGE OF PALESTINE,
CRAWFORD COUNTY, ILLINOIS, FOR 2012

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workmen employed in any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, Illinois Compiled Statutes 820 ILCS 130/1 through 130/12.

WHEREAS, the aforesaid Act requires that the Village of Palestine investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workmen in the locality of said Village employed in performing construction of public works for said Village.

NOW, THEREFORE, BE IT ORDAINED by the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. To the extent and as required by "An Act regulating wages of laborers, mechanics and other workmen employed in any public works by the State, County, City or any public body or any political subdivision, or by anyone under contract for public work", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Village of Palestine is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Crawford County area as determined by the Department of Labor of the State of Illinois as of June 2012, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the aforesaid Act.

Section 3. The Village Clerk shall publicly post or keep available for inspection by any interested party in the Village of Palestine, Village Hall, Palestine, Illinois, this determination of such prevailing rate of wage.

Section 4. The Village Clerk shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers who wages will be affected by such rates.





Explanations**CRAWFORD COUNTY**

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please check with IDOL.

Oil and chip resealing (O&C) means the application of road oils and liquid asphalt to coat an existing road surface, followed by application of aggregate chips or gravel to coated surface, and subsequent rolling of material to seal the surface.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER, MARBLE FINISHER, TERRAZZO FINISHER

Assisting, helping or supporting the tile, marble and terrazzo mechanic by performing their historic and traditional work assignments required to complete the proper installation of the work covered by said crafts. The term "Ceramic" is used for naming the classification only and is in no way a limitation of the product handled. Ceramic takes into consideration most hard tiles.

COMMUNICATION SYSTEMS TECHNICIAN

Installation, operation, inspection, maintenance, repair, and service

of radio, television, recording, voice sound and vision production and reproduction apparatus, equipment and appliances used for domestic, commercial, education, entertainment and private telephone systems.

ELECTRIC POWER LINEMAN

Construction, maintenance and dismantling of overhead and underground electric power lines, including high voltage pipe type cable work, and associated structures and equipment.

ELECTRIC POWER EQUIPMENT OPERATOR - CLASS 1

Operation of all crawler type equipment D-4 and larger from the ground to assist the Electric Power Linemen in performing their duties.

ELECTRIC POWER EQUIPMENT OPERATORS - CLASS 2

Operation of all other equipment from the ground to assist the Electric Power Linemen in performing their duties.

ELECTRIC POWER GROUNDMAN

Applies to workers who assist the Electric Power Lineman from the ground.

TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Drivers on 2 axle trucks hauling less than 9 ton. Air compressor and welding machines and brooms, including those pulled by separate units, truck driver helpers, warehouse employees, mechanic helpers, greasers and tiremen, pickup trucks when hauling materials, tools, or workers to and from and on-the-job site, and fork lifts up to 6,000 lb. capacity.

Class 2. Two or three axle trucks hauling more than 9 ton but hauling less than 16 ton. A-frame winch trucks, hydrolift trucks, vector trucks or similar equipment when used for transportation purposes. Fork lifts over 6,000 lb. capacity, winch trucks, four axle combination units, and ticket writers.

Class 3. Two, three or four axle trucks hauling 16 ton or more. Drivers on water pulls, articulated dump trucks, mechanics and working forepersons, and dispatchers. Five axle or more combination units.

Class 4. Low Boy and Oil Distributors.

Class 5. Drivers who require special protective clothing while employed on hazardous waste work.

TRUCK DRIVER - OIL AND CHIP RESEALING ONLY.

This shall encompass laborers, workers and mechanics who drive contractor or subcontractor owned, leased, or hired pickup, dump, service, or oil distributor trucks. The work includes transporting materials and equipment (including but not limited to, oils, aggregate supplies, parts, machinery and tools) to or from the job site; distributing oil or liquid asphalt and aggregate; stock piling material when in connection with the actual oil and chip contract. The Truck Driver (Oil & Chip Resealing) wage classification does not

include supplier delivered materials.

OPERATING ENGINEERS - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Power Cranes, Draglines, Derricks, Shovels, Gradalls, Mechanics, Tractor Highlift, Tournadozer, Concrete Mixers with Skip, Tournamixer, Two Drum Machine, One Drum Hoist with Tower or Boom, Cableways, Tower Machines, Motor Patrol, Boom Tractor, Boom or Winch Truck, Winch or Hydraulic Boom Truck, Truck Crane, Tournapull, Tractor Operating Scoops, Bulldozer, Push Tractor, Asphalt Planer, Finishing Machine on Asphalt, Large Rollers on Earth, Rollers on Asphalt Mix, Ross Carrier or similar Machine, Gravel Processing Machine, Asphalt Plant Engineer, Paver Operator, Dredging Equipment, or Dredge Engineer, or Dredge Operator, Central Mix Plant Engineer, CMI or similar type machine, Concrete Pump, Truck or Skid Mounted, Tower Crane, Engineer or Rock Crusher Plant, Concrete Plant Engineer, Ditching Machine with dual attachment, Tractor Mounted Loaders, Cherry Picker, Hydro Crane, Standard or Dinkey Locomotives, Scoopmobiles, Euclid Loader, Soil Cement Machine, Back Filler, Elevating Machine, Power Blade, Drilling Machine, including Well Testing, Caissons, Shaft or any similar type drilling machines, Motor Driven Paint Machine, Pipe Cleaning Machine, Pipe Wrapping Machine, Pipe Bending Machine, Apsco Paver, Boring Machine, (Head Equipment Greaser), Barber-Greene Loaders, Formless Paver, (Well Point System), Concrete Spreader, Hydra Ax, Span Saw, Marine Scoops, Brush Mulcher, Brush Burner, Mesh Placer, Tree Mover, Helicopter Crew (3), Piledriver-Skid or Crawler, Stump Remover, Root Rake, Tug Boat Operator, Refrigerating Machine, Freezing Operator, Chair Cart-Self-Propelled, Hydra Seeder, Straw Blower, Power Sub Grader, Bull Float, Finishing Machine, Self-Propelled Pavement Breaker, Lull (or similar type Machine), Two Air Compressors, Compressors hooked in Manifold, Overhead Crane, Chip Spreader, Mud Cat, Sull-Air, Fork Lifts (except when used for landscaping work), Soil Stabilizer (Seaman Tiller, Bo Mag, Rago Gator, and similar types of equipment), Tube Float, Spray Machine, Curing Machine, Concrete or Asphalt Milling Machine, Snooper Truck-Operator, Backhoe, Farm Tractors (with attachments), 4 Point Lift System (Power Lift or similar type), Skid-Steer (Bob Cat or similar type), Wrecking Shears, Water Blaster.

Class 2. Concrete Mixers without Skips, Rock Crusher, Ditching Machine under 6', Curbing Machine, One Drum Machines without Tower or Boom, Air Tugger, Self-Propelled Concrete Saw, Machine Mounted Post Hole Digger, two to four Generators, Water Pumps or Welding Machines, within 400 feet, Air Compressor 600 cu. ft. and under, Rollers on Aggregate and Seal Coat Surfaces, Fork Lift (when used for landscaping work), Concrete and Blacktop Curb Machine, One Water Pump, Oilers, Air Valves or Steam Valves, One Welding Machine, Truck Jack, Mud Jack, Gunnite Machine, House Elevators when used for hoisting material, Engine Tenders, Fireman, Wagon Drill, Flex Plane, Conveyor, Siphons and Pulsometer, Switchman, Fireman on Paint Pots, Fireman on Asphalt Plants, Distributor Operator on Trucks, Tampers, Self-Propelled Power Broom, Striping Machine (motor driven), Form Tamper, Bulk Cement Plant, Equipment Greaser, Deck Hands, Truck Crane Oiler-Driver, Cement Blimps, Form Grader, Temporary Heat, Throttle Valve, Super Sucker (and similar type of equipment).

Other Classifications of Work:

For definitions of classifications not otherwise set out, the

Department generally has on file such definitions which are available. If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.





D. Temporary Permits – Golf Carts

1. No person shall operate a motorized golf cart while visiting in the Village of Palestine, or camping in the Palestine Leaverton Park, without first obtaining a Temporary Permit from the Village Clerk (or designee), as provided herein. Temporary Permits shall be granted for a specific period of time. The cost of a Temporary Permit is a minimum fee of \$15.00, for one day, or \$25.00 for a five (5) day permit. Insurance coverage is to be verified in effect by the Village Clerk (or designee).
2. Every application for a Temporary Permit shall be made on a form supplied by the Village of Palestine, and shall contain the following information:
 - a. The name and address of the applicant(s).
 - b. Name of Liability Insurance Carrier, and agent, along with a copy of said applicable liability insurance coverage policy, and card, specifically for the golf cart to be operated on the Village of Palestine streets.
 - c. The serial number, make, model, and description of the golf cart.
 - d. Signed General Release of Liability, Waiver, Discharge and Covenant not to sue by applicant releasing the Village of Palestine, the County of Crawford, the Township of LaMotte, and all other governmental entities which have approved the operation of golf carts on their roadways of and from all liability for direct, indirect, special, incidental or consequential damages, whether arising in court, contract or any other legal theories, in connection with or arising out of the operator's use of a golf cart, and, in addition, the operator(s) shall save, hold harmless and indemnify such governmental entities against any and all liability, claims, causes of action and costs of whatsoever kind and nature, including death, resulting from,

arising out of, or occurring in connection with the use of a golf cart pursuant to this Ordinance, or any other Ordinance of the Village of Palestine, Illinois.

e. Such other information as the Village may require.

3. No Temporary Permit shall be granted unless the following conditions are met:

- a. The golf cart must be inspected by the Village Chief of Police (or designee) to insure that the vehicle is safe to operate on Village Streets and is in compliance with the requirements of this Ordinance.
- b. The handicapped applicant must submit a certificate signed by a physician, that said handicapped applicant is able to safely operate a motorized golf cart on the roadways designated.
- c. The applicant must provide evidence of insurance in compliance with the provisions of Illinois Statutes regarding minimum liability insurance for passenger motor vehicles to be operated on the roads of the State of Illinois.

The Village Board of Trustees may suspend or revoke a Temporary Permit granted hereunder upon a finding that the holder of said Temporary Permit has violated any of the provisions of this Ordinance or if there is evidence that the permittee cannot safely operate the motorized golf cart on the designated roadways.

Every person operating a golf cart pursuant to Temporary Permit hereunder on designated Village Streets has all the rights and duties applicable to a driver of any other vehicle pursuant to the State Highway Traffic Laws and Regulations except when those provisions cannot reasonably be applied to motorized golf carts.



BE IT ORDAINED by the President and Board of Trustees of The Village of Palestine, Crawford County, Illinois, that CHAPTER 7, SEWER SERVICE, Section 7.07 SEWER USE RATES of the Palestine Village Code, as amended, be, and the same is hereby amended to be as follows:

7.07 SEWER USE RATES. These are established rates or charges for the use of and services supplied by the sanitary sewerage system of the Village of Palestine, as follows:

CLASSIFICATION AND MONTHLY CHARGES

Domestic: (Either permanent or mobile structure):

For each unit of residence of human habitation, whether whether permanent or mobile, each mobile home, apartment or dwelling adapted for residential use being considered one unit:	\$ 42.00 Quarterly

For churches, a flat charge of	\$ 42.00 Quarterly

For institutions a charge of \$1.25 per month for each toilet installation in excess of one, plus a flat of:	\$ 42.00 Quarterly

Quarterly/Monthly rates shall determined by the nature of usage of the sewer of the Village. The fact that multiple dwelling or mercantile units may be discharged in a common sewer outlet before discharging in the Village sewer shall not relieve the individual users or owners hereof from responsibility for the quarterly/monthly flat charges herein fixed.

Stores, offices, mercantile and industrial establishments not otherwise classified):

For toilet or sink or lavatory installation, not to exceed two of each	\$ 51.00 Quarterly
For public laundries (with or without restroom facilities	\$123.00 Quarterly
For combined grocery store, public laundry and car wash	\$150.00 Quarterly

Lodge and Club room:

For toilet or sink or lavatory installation, not to exceed two of each	\$ 42.00 Quarterly
For toilet or sin or lavatory installation, exceeding two of each	\$ 93.00 Quarterly

Public buildings, schools and parks:

Garages or service stations without wash racks or floor drains	\$ 42.00 Quarterly
Garage or service stations with wash racks or floor drains	\$ 51.00 Quarterly
Car wash (with or without restroom facilities)	\$ 25.00 Quarterly

Restaurants, taverns, and soft drink parlors:

For toilet or sink or lavatory installation, not to exceed two of each	\$ 51.00 Quarterly

Creameries, meat packing plants, poultry houses, and other waste producing industries not otherwise classified:

For any toilet or drain installations	\$ 60.00 Quarterly

Rural connections (a rural connection is one where the sewer usage originates outside the Village limits:	\$ 51.00 Quarterly

In an industrial installation where the use of water is large, the rate for sewerage use shall be subject to revision on account of quantity discharged into sewers and the strength or treatment demand of the sewage. The basis of any rate to be applied in such cases shall be the relation of treatment to demand and quantity of waste discharge into sewers as compared with sewage from household establishments and the rate shall be in equitable proportions.

The Sewer Deposit Fee will be in effect for both renters and property owners alike. The deposit fee will be in the amount of \$40.00 and will be refundable at the time the residence is vacated, less any amount of sewer fees due/


This Ordinance shall be effective for sewerage service commencing on July 1, 2012.

ORDINANCE NO. 2012 - O - 15

AN ORDINANCE ESTABLISHING AN OPT-OUT ELECTRICITY AGGREGATION PROGRAM AND APPROVING THE VILLAGE OF PALESTINE'S ELECTRICITY AGGREGATION PROGRAM PLAN OF OPERATION AND GOVERNANCE

WHEREAS, the Village Board finds that the best interests of the Village of Palestine are served by establishing an opt-out electricity aggregation program and implementing the program according to the terms of the Illinois Power Agency Act, 20 ILCS 3855/1-1 *et seq.*; and

WHEREAS, Section 1-92 of the Illinois Power Agency Act, 20 ILCS 3855/1-92, requires the City to develop a plan of operation and governance for the electricity aggregation program,

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF PALESTINE, CRAWFORD COUNTY, ILLINOIS, as follows:

Section 1. The Village Board does hereby establish an opt-out electricity aggregation program for the residential and small commercial retail electrical loads within the Village of Palestine.

Section 2. The Village's Electricity Aggregation Program Plan of Operation and Governance, in substantially the form of the copy of said Plan attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 3. The Village's electricity aggregation program shall be operated and governed in accordance with said Electricity Aggregation Program Plan of Operation and Governance, the applicable provisions of the Illinois Power Agency Act, and any applicable rules and regulations that are now or in the future adopted pursuant to the Act.



ORDINANCE NO. 2012-O- 16

**AN ORDINANCE AUTHORIZING EXECUTION OF A SERVICE AGREEMENT
WITH THE LOWEST RESPONSIBLE BIDDER FOR THE SUPPLY OF
ELECTRICITY FOR RESIDENTIAL AND SMALL COMMERCIAL RETAIL
CUSTOMERS WHO DO NOT OPT-OUT OF SUCH A PROGRAM**

(Municipal electric aggregation)

WHEREAS, Section 1-92 of the Illinois Power Agency Act, 20 ILCS 3855/1-92, permits a municipality, if authorized by referendum, to adopt an ordinance by which it may operate a program to solicit bids and enter into service agreements for the sale and purchase of electricity and related services and equipment to residential and small commercial customers who do not opt-out of such a program; and

WHEREAS, the Village of Palestine ("Village"), in a referendum held on November 6, 2012, submitted the public question of whether it should operate the program as an opt-out program; and

WHEREAS, the referendum passed by a majority vote of the qualified electors voting on the question; and

WHEREAS, the Village Board finds that the best interests of the Village are served by entering into an agreement with the lowest responsible bidder, pursuant to 20 ILCS 3855/1-92, to aggregate the residential and small commercial retail electric loads located within the Village and to arrange for competitive electric supply to these retail electrical accounts; and

WHEREAS, because electricity is a commodity for which supply bids typically are made each morning and expire the same day at the close of business, the Village must act promptly to accept any such desired bid in order to contractually guarantee a per kilowatt hour electric rate for its residential and small commercial customers; and

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. The Mayor of the Village of Palestine, Illinois, be and the same is hereby authorized to execute and deliver and the Village Clerk of the Village of Palestine, Illinois, be and the same is hereby authorized to attest to said execution of a service agreement with the lowest responsible bidder for the supply of electricity for residential and small commercial retail customers who do not opt-out of such a program, said execution and attestation to take place within the applicable time constraints required by the bidder; provided, however, that the energy price to be paid per kilowatt hour pursuant to the agreement is less than the default rate currently in effect, resulting in savings for the Village's residential and small commercial retail customers.

Section 2. This Ordinance shall be effective immediately and shall remain in effect until such time as the year 2012 electricity aggregation program electric supplier selection process has been completed.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




