ORDINANCE NO. 2017-O- 61
AN ORDINANCE TO CONDEMN AN UNSAFE AND DANGEROUS
BUILDING AT 206 SOUTH MAIN STREET, PALESTINE, ILLINOIS

BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that it has determined that the building situated upon the premises at 206 South Main Street, Palestine, Illinois, and more particularly described on Exhibit A attached hereto, is unsafe and dangerous and abandoned and should be either put in a safe condition or demolished; and accordingly, said building located at 206 South Main Street, Palestine, Crawford County, Illinois, is hereby declared to be unsafe and dangerous and is condemned, all pursuant to Illinois Compiled Statutes, being 65 ILCS 5/11-31-1, et seq.

BE IT FURTHER ORDAINED that the Village Attorney be directed to commence proceedings under the Unsafe Property Act, as provided for under the laws of the State of Illinois, and to give 15 days written notice by mail to said owners to either place said building in a safe condition or to demolish it and to follow the other procedures as provided by law.



EXHIBIT A

Commencing at a point in the West line of Lot numbered 121 in the Original Town, now Village of Palestine, In the County of Crawford and State of Illinois, 25 feet South of the Northwest corner of said Lot 121, thence East parallel to the South line of said Lot, 142 feet to the alley, thence North 27 feet and 3 inches on the East line of said Lot to the center of the South wall of the brick building owned by George J. Dickinson on September 9, 1913 and located on Lot 116 adjoining said 121, thence West on a line parallel to the South line of said last mentioned Lot, 142 feet to the West line of said Lots, thence 27 feet and 3 inches South on West line of said Lots to the place of beginning, including the North One-half of the South wall of the brick building situated on said premises on said 9th day of September, 1913, it being the intention of this Deed to convey both the upper and lower stories of the mercantile building presently located on the described premises.


Commencing at a point on the West line of Lot number 121 in the Original Town, now Village of Palestine, Illinois, at a point 25 feet and 8 inches North of the Southwest corner of said Lot (said commencement point being 4 inches North of the Southwest corner of the brick building erected on the middle one-third of said Lot by E. E. Mattox) thence East on a line parallel to said South line of said building 142 feet to the East line of said Lot, thence North on the East line of said Lot to a point 25 feet South of the Northeast corner of said Lot, thence West 142 feet to a point on the West line of said Lot 25 feet South of the Northwest corner of said Lot, and thence South about 24 feet and 4 inches to the place of beginning. Also the perpetual right to the use of the mutual ownership in a permanent stairway 4 feet wide, the North line of said stairway to be 25 feet and 4 Inches North of the Southwest corner of said Lot 121, said stairway running East from the street 26 feet and rising 14 feet In height with a space above of 8 feet and 6 inches above the steps of said stairway and over an ample landing at the head of said stairway, which said stairway is to be built by the adjoining owners of the land herein conveyed and the land lying immediately South of the land herein conveyed at the time a new building shall be erected on that part of said Lot lying immediately South of the land herein conveyed, said stairs when erected to be used and maintained by the owners thereof jointly. 

ORDINANCE NO. 2017-O-02

AN ORDINANCE TO AMEND CHAPTER 14,
POLLUTION CONTROL, GARBAGE, AND REFUSE;
SUBPARAGRAPH 14.09: LEAVES AND REFUSE; FIRES,
OF THE PALESTINE VILLAGE CODE

WHEREAS, the Board of Trustees of Palestine, Illinois, has the power to regulate the Code pertaining to the POLLUTION CONTROL, GARBAGE, AND REFUSE, CHAPTER 14, of the Palestine Code Book.

WHEREAS, the Board of Trustees of Palestine, Illinois, has determined certain regulations regarding the Palestine Village Code are necessary and proper for the welfare of the Village and its inhabitants.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 14, Subparagraph 14.09 LEAVES AND REFUSE; FIRES, be, and it is hereby amended such that it shall be as follows:

14.09 LEAVES AND REFUSE; FIRES. No burning of leaves, refuse or other fires shall be permitted in the Village; PROVIDED, HOWEVER, that controlled wood fires for cooking and aesthetics shall be permitted so long as they are contained and attended by the adult person responsible therefore, who shall maintain a fire extinguisher as approved by the sanitary disposal board, or sufficient water at the scene to extinguish the fire. Any such fires as permitted herein shall be completely extinguished by 10:00 P.M., of the day of the fire.

BE IT FURTHER ORDAINED that if any Section, Paragraph, Subdivision, Clause, Sentence or Provision of this Ordinance shall be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not effect, impair, invalidate, or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

BE IT FURTHER ORDAINED that any person violating this Ordinance shall upon conviction be subject to a fine of not less than \$100.00 nor more than \$750.00, and the cost of prosecution and attorney's fees of the Village in a minimum amount of \$175.00 per hour.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.



AN ORDINANCE TO AMEND CHAPTER 34, LIQUOR,
SECTION 34.06 CLASSES OF LICENSES: FEES OF
THE PALESTINE VILLAGE CODE

WHEREAS, The Board of Trustees of Palestine, Illinois, has the power to regulate the Code Pertaining to the Classes and Fees for Liquor establishments, Pursuant to Illinois Compiled Statues, Chapter 235, Article I, as amended from time to time:

WHEREAS, The Board of Trustees of Palestine, Illinois, has determined certain regulations regarding the Palestine Village Code are necessary and proper for the welfare of the Village and its inhabitants.

NOW, THEREFORE, BE IT ORDAINED by The Board of Trustees of the Village of Palestine, Crawford County, Illinois, that it does hereby amend Chapter 34, Liquor, Section 34.06 CLASSES OF LICENSES; fees of the Palestine Village Code to be as follows:

CLASS A: A license which authorizes the retail sale on the premises of alcoholic liquor, either by the drink or in the original package. The annual fee for such license is \$1,000.00. There shall be no more than one Class A License in effect in the Village at one time.

CLASS A-1: A license which combines the authorized sale of alcoholic beverages as otherwise permitted by separate Class A, Class B, and Class C Licenses, as described herein. The annual fee for such Class A-1 License is \$1,100.00. There shall be no more than one Class A-1 License in effect in the Village at one time.

CLASS B: A license which authorizes the retail sale on the premises only, of beer and wine only. The annual fee for such license is \$500.00. There shall be no more than two Class B Licenses in effect in the Village at one time.

CLASS C: A license which authorizes the retail sale, in the original package only, of all beer, malt beverages, and wine, not for consumption on the premises. The annual fee for such license is \$500.00. There shall be no more than one Class C License in effect in the Village at one time.

CLASS C-1: A license which authorizes the retail sale, in the original package only, of all beer, malt beverages, wine, and spirits, not for consumption on the premises. The annual fee for such license is \$750.00. There shall be no more than one Class C-1 License in effect in the Village at one time.

CLASS D: A license which authorizes the retail sale, specifically therein, of alcoholic beverages, to be served from the bottle or container, or by the drink, for consumption ON THE PREMISES ONLY, to the members of the licensee only, and their bona fide guests, who shall accompany them, and may only be issued to regularly constituted units of the American Legion, Veterans of Foreign Wars, Fraternal Order of the Eagles, Fraternal Order of the AMVETS, Country Club, and other orders and clubs of nationwide membership, who maintain club rooms. The annual fee for such license shall be \$750.00. There shall be no more than TWO Class D Licenses in effect in the Village at one time.

WINERY LICENSE: A license which is otherwise provided for in Chapter 34, Liquor, Section 34.33 hereof.

BE IT FURTHER ORDAINED that any person, firm or corporation which violates any provision of this Ordinance shall, upon conviction, be subject to a fine of not less than \$55.00 nor more than \$750.00, attorney's fees in the minimum amount of \$175.00, and the cost of prosecution.

AN ORDINANCE TO ESTABLISH THE PREVAILING RATE
OF WAGES WITHIN THE VILLAGE OF PALESTINE,
CRAWFORD COUNTY, ILLINOIS

WHEREAS, the State of Illinois has enacted “An Act regulating wages of laborers, mechanics and other workmen employed in any public body or any political subdivision or by anyone under contract for public works”, approved June 26, 1941, as amended, Illinois Compiled Statutes 820 ILCS 130/1 through 130/12.

WHEREAS, the aforesaid Act requires that the Village of Palestine investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workmen in the locality of said Village employed in performing construction of public works for said Village.

NOW, THEREFORE, BE IT ORDAINED by the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. To the extent and as required by “An Act regulating wages of laborers, mechanics and other workmen employed in any public works by the State, County, City or any public body or any political subdivision, or by anyone under contract for public work”, approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Village of Palestine is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Crawford County area as determined by the Department of Labor of the State of Illinois as of July 2015, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the aforesaid Act.

Section 3. The Village Clerk shall publicly post or keep available for inspection by any interested party in the Village of Palestine, Village Hall, Palestine, Illinois, this determination of such prevailing rate of wage.

Section 4. The Village Clerk shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 5. The Village Clerk shall promptly file a certified copy of this Ordinance with both the Secretary of State and the Department of Labor of the State of Illinois.

Explanations

CRAWFORD COUNTY

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please

check with IDOL.

Oil and chip resealing (O&C) means the application of road oils and liquid asphalt to coat an existing road surface, followed by application of aggregate chips or gravel to coated surface, and subsequent rolling of material to seal the surface.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER, MARBLE FINISHER, TERRAZZO FINISHER

Assisting, helping or supporting the tile, marble and terrazzo mechanic by performing their historic and traditional work assignments required to complete the proper installation of the work covered by said crafts. The term "Ceramic" is used for naming the classification only and is in no way a limitation of the product handled. Ceramic takes into consideration most hard tiles.

COMMUNICATION SYSTEMS TECHNICIAN

Installation, operation, inspection, maintenance, repair, and service of radio, television, recording, voice sound and vision production and reproduction apparatus, equipment and appliances used for domestic, commercial, education, entertainment and private telephone systems.

ELECTRIC POWER LINEMAN

Construction, maintenance and dismantling of overhead and underground electric power lines, including high voltage pipe type cable work, and associated structures and equipment.

ELECTRIC POWER EQUIPMENT OPERATOR - CLASS 1

Operation of all crawler type equipment D-4 and larger from the ground to assist the Electric Power Linemen in performing their duties.

ELECTRIC POWER EQUIPMENT OPERATORS - CLASS 2

Operation of all other equipment from the ground to assist the

Electric Power Linemen in performing their duties.

ELECTRIC POWER GROUNDMAN

Applies to workers who assist the Electric Power Lineman from the ground.

TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Drivers on 2 axle trucks hauling less than 9 ton. Air compressor and welding machines and brooms, including those pulled by separate units, truck driver helpers, warehouse employees, mechanic helpers, greasers and tiremen, pickup trucks when hauling materials, tools, or workers to and from and on-the-job site, and fork lifts up to 6,000 lb. capacity.

Class 2. Two or three axle trucks hauling more than 9 ton but hauling less than 16 ton. A-frame winch trucks, hydrolift trucks, vector trucks or similar equipment when used for transportation purposes.

Fork lifts over 6,000 lb. capacity, winch trucks, four axle combination units, and ticket writers.

Class 3. Two, three or four axle trucks hauling 16 ton or more. Drivers on water pulls, articulated dump trucks, mechanics and working forepersons, and dispatchers. Five axle or more combination units.

Class 4. Low Boy and Oil Distributors.

Class 5. Drivers who require special protective clothing while employed on hazardous waste work.

SURVEY WORKER - Operated survey equipment including data collectors, G.P.S. and robotic instruments, as well as conventional levels and transits.

TRUCK DRIVER - OIL AND CHIP RESEALING ONLY.

This shall encompass laborers, workers and mechanics who drive contractor or subcontractor owned, leased, or hired pickup, dump, service, or oil distributor trucks. The work includes transporting materials and equipment (including but not limited to, oils, aggregate supplies, parts, machinery and tools) to or from the job site; distributing oil or liquid asphalt and aggregate; stock piling material when in connection with the actual oil and chip contract. The Truck Driver (Oil & Chip Resealing) wage classification does not include supplier delivered materials.

OPERATING ENGINEERS - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION

Class 1. Draglines, Derricks, Shovels, Gradalls, Mechanics, Tractor Highlift, Tournadozer, Concrete Mixers with Skip, Tournamixer, Two Drum Machine, One Drum Hoist with Tower or Boom, Cableways, Tower Machines, Motor Patrol, Boom Tractor, Boom or Winch Truck, Winch or Hydraulic Boom Truck, Tournapull, Tractor Operating Scoops, Bulldozer, Push Tractor, Asphalt Planer, Finishing Machine on Asphalt, Large Rollers on Earth, Rollers on Asphalt Mix, Ross Carrier or similar Machine, Gravel Processing Machine, Asphalt Plant Engineer, Paver Operator, Dredging Equipment, or Dredge Engineer, or Dredge Operator,

Central Mix Plant Engineer, CMI or similar type machine, Concrete Pump, Truck or Skid Mounted, Engineer or Rock Crusher Plant, Concrete Plant Engineer, Ditching Machine with dual attachment, Tractor Mounted Loaders, Hydro Crane, Standard or Dinkey Locomotives, Scoopmobiles, Euclid Loader, Soil Cement Machine, Back Filler, Elevating Machine, Power Blade, Drilling Machine, including Well Testing, Caissons, Shaft or any similar type drilling machines, Motor Driven Paint Machine, Pipe Cleaning Machine, Pipe Wrapping Machine, Pipe Bending Machine, Apsco Paver, Boring Machine, (Head Equipment Greaser), Barber-Greene Loaders, Formless Paver, (Well Point System), Concrete Spreader, Hydra Ax, Span Saw, Marine Scoops, Brush Mulcher, Brush Burner, Mesh Placer, Tree Mover, Helicopter Crew (3), Piledriver-Skid or Crawler, Stump Remover, Root Rake, Tug Boat Operator, Refrigerating Machine, Freezing Operator, Chair Cart- Self-Propelled, Hydra Seeder, Straw Blower, Power Sub Grader, Bull Float, Finishing Machine, Self-Propelled Pavement Breaker, Lull (or similar type Machine), Two Air Compressors, Compressors hooked in Manifold, Chip Spreader, Mud Cat, Sull-Air, Fork Lifts (except when used for landscaping work), Soil Stabilizer (Seaman Tiller, Bo Mag, Rago Gator, and similar types of equipment), Tube Float, Spray Machine, Curing Machine, Concrete or Asphalt Milling Machine, Snooper Truck-Operator, Backhoe, Farm

Tractors (with attachments), 4 Point Lift System (Power Lift or similar type), Skid-Steer (Bob Cat or similar type), Wrecking Shears, Water Blaster.

Class 2. Concrete Mixers without Skips, Rock Crusher, Ditching Machine under 6', Curbing Machine, One Drum Machines without Tower or Boom, Air Tugger, Self-Propelled Concrete Saw, Machine Mounted Post Hole Digger, two to four Generators, Water Pumps or Welding Machines, within 400 feet, Air Compressor 600 cu. ft. and under, Rollers on Aggregate and Seal Coat Surfaces, Fork Lift (when used for landscaping work), Concrete and Blacktop Curb Machine, One Water Pump, Oilers, Air Valves or Steam Valves, One Welding Machine, Truck Jack, Mud Jack, Gunnite Machine, House Elevators when used for hoisting material, Engine Tenders, Fireman, Wagon Drill, Flex Plane, Conveyor, Siphons and Pulsometer, Switchman, Fireman on Paint Pots, Fireman on Asphalt Plants, Distributor Operator on Trucks, Tampers, Self-Propelled Power Broom, Striping Machine (motor driven), Form Tamper, Bulk Cement Plant, Equipment Greaser, Deck Hands, Truck Crane Oiler-Driver, Cement Blimps, Form Grader, Temporary Heat, Throttle Valve, Super Sucker (and similar type of equipment).

Class 3. Power Cranes, Truck or Crawler Crane, Rough Terrain Crane (Cherry Picker), Tower Crane, Overhead Crane.

Other Classifications of Work:

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are available.

If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer,

operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.



AN ORDINANCE TO AMEND CHAPTER 12A
OF THE PALESTINE VILLAGE CODE
CANNABIS AND SYNTHETIC ALTERNATIVE DRUGS

WHEREAS, the municipal boundaries of the Village of Palestine have seen the use of cannabis, synthetic cannabinoids and synthetic stimulants; and

WHEREAS, many of the types of synthetic cannabinoids and synthetic stimulants are not banned by the federal government; and

WHEREAS, law enforcement of the Village of Palestine has seen detrimental effects caused by the use of cannabis, synthetic cannabinoids and synthetic stimulants; and

WHEREAS, the Village of Palestine finds that products containing synthetic cannabinoids and synthetic stimulants are attractive to children and young adults due to their availability in small packages at minimal costs, as well as due to the names being given to these substances which are intended to appeal to children and young adults, as set forth on Exhibit A attached hereto; and

WHEREAS, citizens in the Village of Palestine have reported use of cannabis, synthetic cannabinoids and synthetic stimulants by others; and

WHEREAS, the Village of Palestine deems it necessary and desirable to prohibit the sale, delivery, possession and use of cannabis and products containing synthetic cannabinoids and synthetic stimulants.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that it does hereby amend Chapters 12A and 12B of the PALESTINE VILLAGE CODE, so that such chapters shall be, in their entirety, as follows:

12A.01 DEFINITIONS.

All defined terms concerning cannabis used in this chapter which are not expressly defined herein shall have the meaning ascribed to such term in the Cannabis Control Act, as used in this chapter, unless the context otherwise requires.

CANNABIS: Shall have the meaning ascribed to it in section 3 of the Cannabis Control Act, as if that definition were incorporated herein.

DELIVER OR DELIVERY: The actual, constructive or attempted transfer of possession, with or without consideration, whether or not there is an agency relationship.

DRUG PARAPHERNALIA:

A. All equipment, products and materials of any kind which are used, intended for use, in planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing, processing, preparing, testing, analyzing, packaging, repackaging, storing, containing, concealing, injecting, ingesting, inhaling or otherwise introducing into the human body cannabis in violation of the Cannabis Control Act. It includes, but is not limited to:

1. Kits used, intended for use or designed for use in manufacturing, compounding, converting, producing, processing or preparing cannabis.
2. Isomerization devices used, intended for use or designed for use in increasing the potency of any species of plant which is cannabis.
3. Testing equipment used, intended for use or designed for use in identifying or in analyzing the strength, effectiveness or purity of cannabis.
4. Scales and balances used, intended for use or designed for use in weighing or measuring cannabis.
5. Diluents and adulterants, such as quinine, hydrochloride, mannitol, mannite, dextrose and lactose used, intended for use or designed for use in cutting cannabis.
6. Separation gins and sifters used, intended for use or designed in removing twigs and seeds from, or in otherwise cleaning or refining cannabis.
7. Blenders, bowls, containers, spoons and mixing devices used, intended for use or designed for use in compounding cannabis.
8. Capsules, balloons, envelopes and other containers used, intended for use or designed for use in packaging small quantities of cannabis.
9. Containers and other objects used, intended for use or designed for use in storing or concealing cannabis.

10. Hypodermic syringes, needles and other objects used, intended for use or designed for use in parenterally injecting cannabis into the human body.

11. Objects used, intended for use or designed for use in ingesting, inhaling or otherwise introducing marijuana into the human body, such as:

- a. Metal, wooden, acrylic, glass, stone, plastic or ceramic pipes with or without screens, permanent screens, or punctured metal bowls.
- b. Water pipes.
- c. Carburetion tubes and devices.
- d. Smoking and carburetion masks.
- e. Roach clips, meaning objects used to hold burning material, such as a marijuana cigarette, that has become too small or too short to be held in the hand.
- f. Miniature cocaine spoons and cocaine vials.
- g. Chamber pipes.
- h. Carburetor pipes.
- i. Electric pipes.
- j. Air driven pipes.
- k. Chillums.
- l. Bongs.
- m. Ice pipes or chillers.

B. In determining whether an object is "drug paraphernalia," a court or other authority should consider, in addition to all other logically relevant factors, the following:

1. Statements by an owner or by anyone in control of the object concerning its use.

2. Prior convictions, if any, of an owner or of anyone in control of the object, under any state or federal law relating to any controlled substance.

3. The proximity of the object in time and space to direct violation of this chapter.

4. The proximity of the object to cannabis.
5. The existence of any residue of cannabis on the object.
6. Direct or circumstantial evidence of the intent of an owner or of anyone in control of the object to deliver it to persons whom he knows or should reasonably know intend to use the object to facilitate a violation of the Cannabis Control Act. The innocence of an owner or of anyone in control of the object as to a direct violation of the Cannabis Control Act shall not prevent a finding that the object is intended for use or assigned for use as "drug paraphernalia."
7. Instructions, oral or written, provided with the object concerning its use.
8. Descriptive materials accompanying the object which explain or depict its use.
9. National and local advertising concerning its use.
10. The manner in which the object is displayed for sale.
11. Whether the owner or anyone in control of the object is a legitimate supplier of like or related items to the community, such as a licensed distributor or dealer of tobacco products.
12. Direct or circumstantial evidence of the ratio of sales of the object(s) to the total sales of the business enterprise.
13. The existence and scope of legitimate uses for the object in the community.
14. Expert testimony concerning its use.

MANUFACTURER: The production, preparation, propagation, compounding, conversion or processing of cannabis, either directly or indirectly, by extraction from substances of natural origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis, and includes any packaging or repackaging of cannabis or labeling of its container, except, that "manufacturer" does not include the preparation, compounding, packaging or labeling of cannabis as an incident to lawful research, teaching or chemical analysis and not for sale.

PERSON: Any individual, corporation, government or governmental subdivision or agency, business trust, estate, trust partnership or association, or any other entity.

PRODUCE OR PRODUCTION: Planting, cultivating, tending or harvesting.

STATE: Includes the State of Illinois and any state, district, commonwealth, territory,

insular possession thereof, and any area subject to the legal authority of the United States of America.

SYNTHETIC CANNABINOIDS: Any laboratory-created compound that functions similar to the active ingredient in marijuana, tetrahydrocannabinol (THC), including but not limited to, any quantity of a natural or synthetic material, compound, mixture, preparation, substance and their analog containing a cannabinoid receptor agonist, such as:

JWH-007 (1-pentyl-2-methyl-3-(1-naphthoyl)indole);

JWH-015;

((2-Methyl-1-propyl-1H-indol-3-yl)-1-naphthalenylmethanone);

JWH-018 (1-pentyl-3-(1-naphthoyl)indole);

4-Ethylmethcathinone (other name: 4-EMC);

Ethcathinone;

Beta-keto-N-methylbenzodioxolylpropylamine (other names: butylone, bk-MBDB);

Naphthylpyrovalerone (other names: naphyrone, NRG-1);

N,N-dimethylcathinone (other name: metamfepramone);

Alpha-pyrrolidinopropiophenone (other name: alpha-PPP);

4-methoxy-alpha-pyrrolidinopropiophenone (other name: MOPPP);

3,4-methylenedioxy-alpha-pyrrolidinopropiophenone (other name: MDPPP);

Alpha-pyrrolidinovalerophenone (other name: alpha-PVP);

12A.02 UNLAWFUL USE, SELL, OFFER FOR SALE, DELIVERY OR POSSESSION OF CANNABIS OR SYNTHETIC SUBSTANCES

It is unlawful for any person to use, sell, offer for sale, deliver or knowingly possess cannabis or any product containing synthetic cannabinoid or synthetic stimulant.

12A.03 UNLAWFUL USE OR POSSESSION OF DRUG PARAPHERNALIA:

It is unlawful for any person to use or to possess with intent to use drug paraphernalia to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, conceal, inject, ingest, inhale, or otherwise introduce into the human body cannabis, a synthetic cannabinoid or synthetic stimulant.

12A.04 PENALTIES CONCERNING CANNABIS, SYNTHETIC CANNABINOID, SYNTHETIC STIMULANT AND DRUG PARAPHERNALIA:

Any person who violates the provisions of this Ordinance concerning cannabis, synthetic cannabinoid, synthetic stimulant and drug paraphernalia shall be fined in an amount not less than \$400.00 nor more than \$750.00, and the costs of prosecution and the attorney's fee of the VILLAGE OF PALESTINE in a minimum amount of \$175.00 per hour. Of the fine, the sum of \$100.00 shall be deposited to the general fund, and the balance of the fine shall be deposited to a general fund account designated PALESTINE POLICE DEPARTMENT ADMINISTRATIVE FUND, to be used for the administration and enforcement of Ordinance violations.

12A.05:

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

12A.06:

All prior Ordinances and Resolutions in conflict or inconsistent herewith, are hereby expressly repealed only to the extent of such conflict or inconsistency.

12A.07:

This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.



ORDINANCE NO. 2017-O- 08

AN ORDINANCE TO AMEND CHAPTER 34, LIQUOR,
TO ADD SECTION 34.34 – LICENSE AND
REGULATION OF NANO-BREWERIES

WHEREAS, there exists a Village of Palestine Liquor Code, as amended, regulating and licensing establishments in the incorporated areas of the Village of Palestine that are engaged in the business of selling alcoholic beverages; and

WHEREAS, the Palestine Village Board wishes to create a Nano-brewery license classification, to establish a Nano-brewery license fee, and to make regulations concerning Nano-brewery licenses; and

WHEREAS, the Board of Trustees of the Village of Palestine find it to be in the best interest of the public health, safety and welfare of the citizens of Palestine, Illinois, to create a Nano-brewery license and to regulate Nano-breweries.

NOW, THEREFORE, be it ordained by the board of trustees of the Village of Palestine, Crawford County, Illinois, as follows:

34.34 LICENSE AND REGULATION OF NANO-BREWERIES

1. This ordinance is in addition to an amendment to the Palestine Liquor Code, being Chapter 34, as amended, and shall govern Nano-brewery licenses and Nano-brewery licensees, and to the extent the provisions hereafter conflict with other provisions of the Palestine Liquor Code, as set forth in Chapter 34, as amended, the provisions hereafter shall supersede and control over such other provisions of the Palestine Liquor Code as to Nano-breweries and Nano-brewery license. The rights

granted Nano-brewery licensees hereunder shall be subject to applicable State and Federal laws.

2. The Local Liquor Control Commissioner may issue a Nano-brewery license for the Village of Palestine only to a person, partnership or corporation engaged or intended to engage in the commercial Nano-beer production business in Palestine, Illinois. A Nano-brewery license issued by the Local Liquor Control Commissioner shall authorize the manufacture, sale, packaging of bulk beer, and the sale, resale, distribution, storage, and wholesale of all types of beer manufactured by the licensee, and other beer derived products for consumption on or off the brewery premises (including buildings and property), but business hours for retail sales shall be restricted to the days and hours detailed hereafter. This license specifically excludes the manufacture, distribution and or sale of wine or liquor. The Nano-brewery license shall allow on-premises sampling of said Nano-beer products to consumers of lawful age during permitted retail sales hours.

A Village of Palestine Nano-brewery licensee possessing an Illinois State Brew Pub Manufacturer's license may also sell Nano-beer to distributors and retailers in Illinois and outside of the State of Illinois to the extent authorized by its Illinois State License and to the extent permitted by federal law. The Nano-brewery licensee may have directional signs placed along public roads that lead to the Nano-brewery premises, with prior approval of the Village of Palestine Board of Trustees. The Nano-brewery licensee shall also have the right to be open for business to the public to sell, at retail, for consumption on or off the premises, of Nano-beer products at the Village of Palestine Nano-brewery licensee's premises, including buildings and property, six (6)

days per week, including Sundays, with Sunday hours being between 12:00 p.m. and 6:00 p.m.

3. The fee for a Nano-brewery license shall be Fifty and No/100 (\$50.00) Dollars per year prior to said Nano-brewery becoming open for retail business to the public, and One Thousand and No/100 (\$1,000.00) Dollars per year for each year after becoming open for public retail business. Therefore, a new license shall be the annual fee prorated to the number of months that have expired since the last prior May 1. The fee for renewal shall be the full annual fee thereafter.

4. All Nano-brewery licenses issued by the Local Liquor Control Commissioner shall be an annual license, and shall expire April 30th following their issuance, and shall state thereon the fact that such license is a license for the manufacture, sale, packaging, resale and wholesale of beer products, the name of the licensee, and the address and description of the premises for which it is granted, the date of its issuance and expiration, shall be duly attested by the Village Clerk and countersigned by the Liquor Commissioner of the Village of Palestine.

5. Any Nano-brewery license issued hereunder shall apply only to the premises, including buildings and lands described in the application, and only one location shall be so described; provided always, that the local Liquor Control Commissioner may endorse on said application and license, permission to abandon the premises described therein and removed to other premises approved by him.

6. The Village Clerk shall collect all Nano-brewery license fees and deposit and administer the same as other license fees collected under the Village of Palestine Liquor Control Code as amended.

7. Any person, partnership, or corporation violating any provisions of this ordinance, or any rule or regulation adopted or issued in pursuance thereof, upon conviction will be subject to a fine of not less than Fifty-Five and no/100 (\$55.00) Dollars nor more than Seven Hundred Fifty and no/100 (\$750.00) Dollars, attorney's fees in the minimum amount of \$175.00 and the cost of prosecution.





BE IT FURTHER ORDAINED that any person, partnership, or corporation violating any provision of this Ordinance, or any rule or regulation adopted or issued in pursuance thereof, upon conviction shall be subject to a fine of not less than Fifty-Five Dollars (\$55.00) nor more than Seven Hundred Fifty Dollars (\$750.00), attorney's fees in the minimum amount of \$175.00 and the costs of prosecution.





