



ORDINANCE NO. 2016-O- 12

AN ORDINANCE TO AMEND CHAPTER 7, SEWER SERVICE,  
SECTION 7.07, SEWER USE RATES, OF THE PALESTINE VILLAGE CODE.

BE IT ORDAINED by the President and Board of Trustees of The Village of Palestine, Crawford County, Illinois, that CHAPTER 7, SEWER SERVICE, Section 7.07 SEWER USE RATES of the Palestine Village Code, as amended, be, and the same is hereby amended to be as follows:

**7.07 SEWER USE RATES.** These are established rates or charges for the use of and services supplied by the sanitary sewerages system of the Village of Palestine, as follows:

**CLASSIFICATION AND MONTHLY CHARGES**

Domestic (either permanent or mobile structure):

For each unit of residence of human habitation, whether Permanent or mobile, each mobile home, apartment or dwelling adapted for residential use being considered one unit.	\$ 45.00 Quarterly
For churches, a flat charge of:	\$ 45.00 Quarterly
For institutions, a charge of \$1.25 per month for each toilet installation in excess of one, plus a flat rate of:	\$ 45.00 Quarterly
For Palestine Grade School	\$141.00 Quarterly
For Palestine High School	\$84.00 Quarterly
For hospitals or nursing homes, a charge of \$1.25 per month for each toilet installation in excess of one, plus a flat rate of:	\$ 100.00 Quarterly
For rooming houses, a charge of \$1.25 per month for each toilet installation in excess of one, plus a flat charge for each separate apartment of:	\$45.00 Quarterly

Quarterly/Monthly rates shall be determined by the nature of usage of the sewer of the Village. The fact that multiple dwelling or mercantile units may be discharged in a common Sewer outlet before discharging in the Village sewer shall not relieve the individual users or Owners hereof from responsibility for the quarterly/monthly flat charges herein fixed.

Stores, offices, mercantile and industrial establishments not otherwise classified:

For toilet or sink or lavatory installation, not to exceed two of each	\$ 54.00 Quarterly
For public laundries (with or without restroom facilities) Including Car Wash	\$ 126.00 Quarterly
For grocery store with one bathroom	\$ 100.00 Quarterly

Lodge and Club room:

For toilet or sink or lavatory installation, not to exceed two of each	\$ 54.00 Quarterly
For toilet or sink or lavatory installation, exceeding two of each	\$ 96.00 Quarterly

Public buildings, schools and parks:

Garages or service stations without wash racks or floor drains	\$ 45.00 Quarterly
Garage or service stations with wash racks or floor drains	\$ 54.00 Quarterly
Car wash (with or without restroom facilities)	\$ 28.00 Quarterly

Restaurants, taverns, and soft drink parlors:

For toilet or sink or lavatory installation, not to exceed two of each	\$ 54.00 Quarterly
For toilet or sink or lavatory installation, exceeding two of each	

Creameries, meat packing plants, poultry houses, and other waste producing industries not otherwise classified:

For any toilet or drain installations	\$ 65.00 Quarterly

Rural connections (a rural connection is one where the sewer usage Originates outside the Village limits:	\$ 54.00 Quarterly

Heavy diesel and gasoline truck and tractor Repair garages	\$ 125.00 Quarterly

In an industrial installation where the use of water is large, the rate for sewerage shall be subject to revision on account of quantity discharged into sewers and the strength or treatment demand of the sewage. The basis of any rate to be applied in such cases shall be the relation of treatment to demand and quantity of water discharge into sewers as compared with sewage from household establishments and the rate shall be in equitable proportions.

The Sewer Deposit Fee will be in effect for both renters and property owners alike. The Deposit Fee will be in the amount of \$45.00 and will be refundable at the time the residence is vacated, less any amount of sewer fees due.

Sewer Connection Fee \$ 400.00 Flat

This Ordinance shall be effective for sewerage service on **January 1, 2017**.





ORDINANCE NO. 2016-O- 1 )

AN ORDINANCE REGARDING TRAVEL, MEAL AND LODGING EXPENSES

WHEREAS, the Illinois General Assembly has recently enacted Public Act 99-0604, known as the "Local Government Travel Expense Control Act;" which Act becomes effective on January 1, 2017; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. The recitals set forth hereinabove shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

Section 2. Definitions:

"Entertainment" includes, but is not limited to, shows, amusements, theaters, circuses, sporting events, or any other place of public or private entertainment or amusement, unless ancillary to the purpose of the program or event.

"Public Business" means expenses incurred in the performance of a public purpose which is required or useful for the benefit of the Village to carry out the responsibilities of Village business.

"Travel" means any expenditure directly incident to official travel by employees and officers of the Village or by wards or charges of the Village involving reimbursement to travelers or direct payment to private agencies providing transportation or related services.

Section 3. The Village shall only reimburse the following types of travel, meal, and lodging expenses incurred by its employees and officers up to the following maximum allowable amounts: out-of-pocket expenses. Alcohol is specifically excluded from reimbursement.

Section 4. No reimbursement of travel, meal or lodging expenses incurred by a Village employee or officer shall be authorized unless the "Travel, Meal and Lodging Expense Reimbursement Request Form," attached hereto and made a part hereof, has been submitted and approved. All documents and information submitted with the form shall be subject to disclosure under the Freedom of Information Act (5 ILCS 140/1 *et. seq.*).

Section 5. Expenses for travel, meals and lodging of: (1) any officer or employee that exceeds the maximum reimbursement allowed under the regulations adopted under Section 3 of this Ordinance or (2) any member of the corporate authorities of the Village may only be approved by roll call vote at an open meeting of

the corporate authorities of the Village. However, in the event of an emergency or other extraordinary circumstances, the corporate authorities may approve more than the maximum allowable expenses set forth above.

Section 6. The Village shall not reimburse any elected official, employee, or officer for any activities which would be considered entertainment. Activities which would otherwise be considered entertainment, but which are excluded from the prohibition on reimbursement due to being ancillary to the purpose of the program or event, may be reimbursed in accordance with the provisions of this Ordinance.

Section 7. Any policy, resolution or ordinance that conflicts with the provisions of this ordinance shall be and is hereby repealed to the extent of such conflict.


Section 8. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.





ORDINANCE NO. 2016-O-10

AN ORDINANCE TO AMEND CHAPTER 41, TRAFFIC, SECTION 41.22, GOLF  
CARTS AND SECTION 41.23, NEIGHBORHOOD VEHICLES,  
OF THE PALESTINE VILLAGE CODE

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has carefully researched through the National Highway Traffic Safety Administration, the regulations under Title 49 C.F.R. Part 571.500, et seq., and the Illinois Vehicle Code with regard to such manners; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois, has determined that this Ordinance shall only apply to matters occurring within the corporate limits of such Village; and

WHEREAS, The Board of Trustees of the Village of Palestine, Illinois, has determined that 4-wheelers and 3-wheelers are all-terrain vehicles designed for off-road use only and are not permitted to operate on streets, roads or highways and accordingly, are not covered by the provisions of this Ordinance.

WHEREAS, by Ordinances Number 2005-O-09 and 2013-O-01, the Board of Trustees of the Village of Palestine has provided for the operation of golf carts and neighborhood vehicles on the streets in the Village of Palestine, Crawford County, Illinois; and

WHEREAS, the Board of Trustees has determined to further amend said Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 41, Traffic, Section 41.22 Golf Carts, and Section 41.23 Neighborhood Vehicles, be, and it is hereby amended to be as follows:

**41.22 GOLF CARTS**

**A: Definitions**

**1. Golf Carts - (625 ILCS 5/11 -1428**

A golf cart shall not be capable of speeds exceeding 20 miles per hour. The definition of golf cart specifically excludes all-terrain vehicles, ATV's, or any vehicle that is not a golf cart.

## **41.23 NEIGHBORHOOD VEHICLES**

### **A: Definitions**

#### **1. Neighborhood Vehicles - (625 ILCS 5/1 - 148.3m)**

A self-propelled electric powered, four-wheeled motor vehicle (or a self-propelled, gasoline powered, four-wheeled motor vehicle with an engine displacement under 1,200 cubic centimeters) that is capable of operating at maximum speed of no more than 25 miles per hour, and which conforms to Federal Regulations under Title 49 C.F.R. Part 571.500. This specifically excludes 3-wheel and 4-wheel all-terrain vehicles which are designed for off-road only, except municipally owned service vehicles.

2. "Village Street" means any of the streets (as designated on the attached map) within the boundaries of the Village of Palestine, except for State and County roads.

3. "State Roads" include Illinois Route 33.

4. "County Roads" include any roads outside the boundaries of the Village Limits of Palestine.

5. The term 'said vehicle(s)' used throughout this Ordinance, unless otherwise defined, shall include Golf Carts and/or Neighborhood Vehicles.

### **B: Requirements**

All persons wishing to operate a said vehicle(s) on the streets of Palestine must ensure compliance with the following requirements:

1. Must have a valid Driver's License.

2. Must have Proof of Liability insurance on said vehicle.

3. Said vehicle(s) must be inspected by Village Police Chief or designated representative.

4. Said vehicle(s) must be equipped with seatbelts, windshield, horn, brakes, turn signals, a steering wheel apparatus, a rearview mirror, red reflective warning devices in the front and rear, a slow moving vehicle emblem (as required of other vehicles in 625 ILCS 5/12-709) on the rear of the vehicle, a headlight that emits a white light that is visible from a distance of 500 feet to the front, a tail lamp that emits a red light visible from at least 100 feet from the rear of the vehicle, and brake lights.

5. When operated on a roadway, said vehicle(s) shall have its headlight and tail lamps lighted.

6. Maximum speed must not exceed 20 miles per hour for Golf Carts; and 25 miles per hour for Neighborhood Vehicles.

7. The only modification of a Golf Cart and/or Neighborhood Vehicle suspension is: A 6 inch lift limit.

8. May cross on any street intersecting with Route 33 when authorized by the State of Illinois Department of Transportation.

9. May only operate on Village Streets and with authorized use of LaMotte Township Roads to and from Palestine Cemetery and Leaverton Park, and County Roads as approved by LaMotte Township and Crawford County, in the original Golf Cart Ordinance (Ordinance No. 2005-O-09).

10. May be operated at any time.

11. May only be operated on designated Village Streets. They shall not be operated in inclement weather nor when visibility is impaired by weather, smoke, fog, or other conditions, or at anytime when there is insufficient light to clearly see persons and vehicle on the roadway at a distance of 500 feet.

12. A person who drives or is in actual physical control of a Golf Cart and/or a Neighborhood Vehicle on a roadway, while under the influence, is subject to Section 11-500 through 11-502 of the Illinois Compiled Statutes (625 ILCS 5/11-500 through 11-502).

13. May not be operated on sidewalks or other public property not accessible to or authorized to vehicular traffic.

14. May not be operated on streets and highways and roads under the jurisdiction of the Illinois Department of Transportation (Illinois Route 33) or the County Highway Department, but may be operated on LaMotte Township Roads to and from Palestine Cemetery and Leaverton Park, and County Roads as approved by LaMotte Township and Crawford County, in the original Golf Cart Ordinance (Ordinance No. 2005-O-09).

### **C: Permits**

1. No person shall operate a Golf Cart or Neighborhood Vehicle in the Village of Palestine without first obtaining a permit from the Village Clerk as provided herein. Permits shall be granted for a period of ONE (1) YEAR and may be renewed annually. The cost of the permit for Golf Carts will be THIRTY-FIVE (\$35.00) DOLLARS; and the cost of the initial inspection for the permit for Neighborhood Vehicles, will be SEVENTY-FIVE (\$75.00) DOLLARS; the cost of an annual permit for Neighborhood Vehicles, thereafter, will be FIFTY (\$50.00) DOLLARS per year. Permits

shall be secured by May 1 of each year, and any permit reissued after May 31 of each year shall require an additional fee of FIVE (\$5) DOLLARS per permit. Insurance coverage is to be verified to be in effect by the Palestine Village Clerk when obtaining and renewing a permit for either the Golf Carts and/or Neighborhood Vehicles.

2. Every application for a permit shall be made on a form supplied by the Palestine Village Clerk and shall contain the following information:

- a. Name, address and phone number of applicant
- b. Name of Insurance Liability Carrier and agent
- c. Serial Number, make, model and description of vehicle
- d. Photocopy of applicable liability insurance card for each vehicle
- e. Signed General Release of Liability, Waiver, Discharges any

covenant, not to sue by applicant, releasing the Village of Palestine, the County of Crawford, the Township of LaMotte and all other governmental entities which have been approved for the operation of said vehicle(s) on their roadways of and from all liability, for direct, indirect, special, incidental or consequential damages, whether arising in court, contract of any other legal theories, in connection with or arising out of the operator's use of said vehicles, and, in addition, this operator shall save, hold harmless and indemnify such governmental entities against any and all liability, claims, causes of action and costs of whatsoever kind and nature, including, without being limited to injury, damage, loss including death, resulting from, arising out of, occurring in connection with the use of said vehicle(s) pursuant to this ordinance or any other ordinance of the Village of Palestine.

- f. Such other information as the Village may require.

3. No permit shall be granted unless the following conditions are met:

- a. The said vehicle(s) must be inspected by the Village Chief of Police (or a designee) to ensure that the vehicle is safe to operate on Village Streets and is in compliance with this Ordinance.

- b. The handicapped applicant must submit a certificate signed by a physician, that the handicapped applicant is able to safely operate a motorized vehicle on the streets and roadways designated.

- c. The applicant must provide evidence of insurance in compliance within the provisions of the Illinois Statutes regarding minimum liability insurance for passenger motor vehicles to be operated on the roads of the State of Illinois.

The Village Chief of Police (or designee), as well as the Village Board of Trustees for the Village of Palestine, Illinois, may suspend or revoke a permit granted hereunder upon a finding that the holder thereof has violated any of the provisions of this Ordinance or if there is evidence that the permittee cannot safely operate the motorized said vehicle(s) on the designated roadways.

Every person operating said vehicle(s) pursuant to permit hereunder on designated Village Streets shall have all the rights and duties applicable to a driver of

any other vehicle pursuant to the State Highway Traffic Laws and Regulations except when those provisions cannot reasonably be applied to motorized vehicles defined as Golf Carts and Neighborhood Vehicles.

Any person who violates any provision of this Ordinance shall upon conviction be subject to a fine of not less than \$55.00 nor more than \$750.00 and the costs of prosecution.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.





ORDINANCE NO. 2016-O- 09

AN ORDINANCE TO AMEND THE  
PALESTINE VILLAGE CODE TO ADD CHAPTER 12B, CANNABIS

BE IT ORDAINED by the Village Board of the Village of Palestine, Crawford  
County, Illinois, that it does hereby amend the PALESTINE CITY CODE to add  
CHAPTER 12B, CANNABIS, as follows:

**12B.01 DEFINITIONS.**

All defined terms used in this chapter which are not expressly defined herein shall have the meaning ascribed to such term in the Cannabis Control Act, as used in this chapter, unless the context otherwise requires.

CANNABIS: Shall have the meaning ascribed to it in section 3 of the Cannabis Control Act, as if that definition were incorporated herein.

DELIVER OR DELIVERY: The actual, constructive or attempted transfer of possession, with or without consideration, whether or not there is an agency relationship.

DRUG PARAPHERNALIA:

A. All equipment, products and materials of any kind which are used, intended for use, in planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing, processing, preparing, testing, analyzing, packaging, repackaging, storing, containing, concealing, injecting, ingesting, inhaling or otherwise introducing into the human body cannabis in violation of the Cannabis Control Act. It includes, but is not limited to:

1. Kits used, intended for use or designed for use in manufacturing, compounding, converting, producing, processing or preparing cannabis.
2. Isomerization devices used, intended for use or designed for use in increasing the potency of any species of plant which is cannabis.
3. Testing equipment used, intended for use or designed for use in identifying or in analyzing the strength, effectiveness or purity of cannabis.
4. Scales and balances used, intended for use or designed for use in weighing or measuring cannabis.

5. Diluents and adulterants, such as quinine, hydrochloride, mannitol, mannite, dextrose and lactose used, intended for use or designed for use in cutting cannabis.
6. Separation gins and sifters used, intended for use or designed in removing twigs and seeds from, or in otherwise cleaning or refining cannabis.
7. Blenders, bowls, containers, spoons and mixing devices used, intended for use or designed for use in compounding cannabis.
8. Capsules, balloons, envelopes and other containers used, intended for use or designed for use in packaging small quantities of cannabis.
9. Containers and other objects used, intended for use or designed for use in storing or concealing cannabis.
10. Hypodermic syringes, needles and other objects used, intended for use or designed for use in parenterally injecting cannabis into the human body.
11. Objects used, intended for use or designed for use in ingesting, inhaling or otherwise introducing marijuana into the human body, such as:
  - a. Metal, wooden, acrylic, glass, stone, plastic or ceramic pipes with or without screens, permanent screens, or punctured metal bowls.
  - b. Water pipes.
  - c. Carburetion tubes and devices.
  - d. Smoking and carburetion masks.
  - e. Roach clips, meaning objects used to hold burning material, such as a marijuana cigarette, that has become too small or too short to be held in the hand.
  - f. Miniature cocaine spoons and cocaine vials.
  - g. Chamber pipes.
  - h. Carburetor pipes.
  - i. Electric pipes.
  - j. Air driven pipes.

- k. Chillums.
- l. Bongs.
- m. Ice pipes or chillers.

B. In determining whether an object is "drug paraphernalia," a court or other authority should consider, in addition to all other logically relevant factors, the following:

1. Statements by an owner or by anyone in control of the object concerning its use.
2. Prior convictions, if any, of an owner or of anyone in control of the object, under any state or federal law relating to any controlled substance.
3. The proximity of the object in time and space to direct violation of this chapter.
4. The proximity of the object to cannabis.
5. The existence of any residue of cannabis on the object.
6. Direct or circumstantial evidence of the intent of an owner or of anyone in control of the object to deliver it to persons whom he knows or should reasonably know intend to use the object to facilitate a violation of the Cannabis Control Act. The innocence of an owner or of anyone in control of the object as to a direct violation of the Cannabis Control Act shall not prevent a finding that the object is intended for use or assigned for use as "drug paraphernalia."
7. Instructions, oral or written, provided with the object concerning its use.
8. Descriptive materials accompanying the object which explain or depict its use.
9. National and local advertising concerning its use.
10. The manner in which the object is displayed for sale.
11. Whether the owner or anyone in control of the object is a legitimate supplier of like or related items to the community, such as a licensed distributor or dealer of tobacco products.
12. Direct or circumstantial evidence of the ratio of sales of the object(s) to the total sales of the business enterprise.

13. The existence and scope of legitimate uses for the object in the community.

14. Expert testimony concerning its use.

**MANUFACTURER:** The production, preparation, propagation, compounding, conversion or processing of cannabis, either directly or indirectly, by extraction from substances of natural origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis, and includes any packaging or repackaging of cannabis or labeling of its container, except, that "manufacturer" does not include the preparation, compounding, packaging or labeling of cannabis as an incident to lawful research, teaching or chemical analysis and not for sale.

**PERSON:** Any individual, corporation, government or governmental subdivision or agency, business trust, estate, trust partnership or association, or any other entity.

**PRODUCE OR PRODUCTION:** Planting, cultivating, tending or harvesting.

**PRODUCT CONTAINING A SYNTHETIC ALTERNATIVE DRUG:** Any product containing a "synthetic cannabinoid", stimulant or psychedelic/hallucinogen as those items are defined herein, or a drug that is misbranded or falsely advertised as a product containing a synthetic alternative drug.

**STATE:** Includes the State of Illinois and any state, district, commonwealth, territory, insular possession thereof, and any area subject to the legal authority of the United States of America.

**SYNTHETIC CANNABINOID:** Any compound that functions similar to the active ingredient in marijuana, tetrahydrocannabinol (THC), including, but not limited to, any quantity of a natural or synthetic material, compound, mixture, preparation, substances and their analog (including isomers, esters, ethers, salts, and salts of isomers) containing a cannabinoid receptor agonist.

#### **12B.02 UNLAWFUL USE OR POSSESSION OF DRUG PARAPHERNALIA:**

It is unlawful for any person to use or to possess with intent to use drug paraphernalia to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, conceal, inject, ingest, inhale, or otherwise introduce into the human body cannabis in violation of the Cannabis Control Act.

#### **12B.03 POSSESSION OF NOT MORE THAN 10 GRAMS OF CANNBIS:**

It is unlawful for any person to knowingly possess not more than 10 grams of any

substance containing cannabis. Any person who violates this section shall be fined in an amount not to be less than Four Hundred Dollars (\$400.00) nor more than Seven Hundred Fifty Dollars (\$750.00), and the costs of prosecution and the attorney's fees of the City in a minimum amount of One Hundred Seventy-five Dollars (\$175.00) per hour. Of the fine, the sum of One Hundred Dollars (\$100.00) shall be deposited to the General Fund, and the balance of the fine shall be deposited to a General Fund Account designated PALESTINE POLICE DEPARTMENT DRUG FUND, to be used for the administration and enforcement of Ordinance violations.

**12B.04 DELIVERY OR INTENT TO DELIVER DRUG PARAPHERNALIA:**

Prohibited Generally: It is unlawful for any person to deliver, possess with intent to deliver or manufacture with intent to deliver drug paraphernalia knowing, or under circumstances where one reasonably should know, that it will be used to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, inject, inhale or otherwise introduce into the human body in violation of the Cannabis Control Act. Any person who violates this section shall be fined in an amount not to be less than Four Hundred Dollars (\$400.00) nor more than Seven Hundred Fifty Dollars (\$750.00), and the costs of prosecution and the attorney's fees of the City in a minimum amount of One Hundred Seventy-five Dollars (\$175.00) per hour. Of the fine, the sum of One Hundred Dollars (\$100.00) shall be deposited to the General Fund, and the balance of the fine shall be deposited to a General Fund Account designated PALESTINE POLICE DEPARTMENT DRUG FUND, to be used for the administration and enforcement of Ordinance violations.

**12B.05**

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**12B.06**

All prior Ordinances and Resolutions in conflict or inconsistent herewith, are hereby expressly repealed only to the extent of such conflict or inconsistency.

**12B.07**

This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workmen employed in any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, Illinois Compiled Statutes 820 ILCS 130/1 through 130/12.

WHEREAS, the aforesaid Act requires that the Village of Palestine investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workmen in the locality of said Village employed in performing construction of public works for said Village.

NOW, THEREFORE, BE IT ORDAINED by the Village of Palestine, Crawford County, Illinois, as follows:

Section 1. To the extent and as required by "An Act regulating wages of laborers, mechanics and other workmen employed in any public works by the State, County, City or any public body or any political subdivision, or by anyone under contract for public work", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Village of Palestine is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Crawford County area as determined by the Department of Labor of the State of Illinois as of July 2015, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the aforesaid Act.

Section 3. The Village Clerk shall publicly post or keep available for inspection by any interested party in the Village of Palestine, Village Hall, Palestine, Illinois, this determination of such prevailing rate of wage.

Section 4. The Village Clerk shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.



ORDINANCE NO. 2016-O- 02

**AN ORDINANCE ADDRESSING THE PAYMENT OF CABLE TELEVISION  
FRANCHISE FEES IN THE VILLAGE OF PALESTINE, ILLINOIS**

WHEREAS, Mediacom Illinois LLC operates a cable television system providing cable television services to households in the Village of Palestine, Illinois authorized under an Authorization to Offer Cable or Video Services granted by the Illinois Commerce Commission on October 17, 2014 pursuant to 220 ILL. COMP. STAT. 5/21-401; and

WHEREAS, 220 ILL. COMP. STAT. 5/21-801 permits the Village to collect service provider fees from a cable operator operating within the Village pursuant to a state authorization; and

WHEREAS, the Village hereby adopts this Ordinance in order to collect service provider fees from Mediacom Illinois LLC.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF PALESTINE, ILLINOIS AS FOLLOWS:

SECTION 1. Mediacom Illinois LLC shall pay an annual service provider fee to the Village in an amount equal to five percent (5%) of annual gross revenues derived from the provision of cable or video service to households located within the Village. The twelve (12) month period for the computation of the service provider fee shall be a calendar year.

SECTION 2. The service provider fee payment shall be due annually and payable within ninety (90) days after the close of the preceding calendar year. Each payment shall be accompanied by a brief report prepared by a representative of the

Grantee showing the basis for the computation. If mailed, the fee shall be considered paid on the date it is postmarked.

SECTION 3. For purposes of the calculation of the service provider fee, "gross revenues" shall mean consideration of any kind or nature, including, without limitation, cash, credits, property, and in-kind contributions received by Mediacom Illinois LLC for the operation of its cable system to provide cable or video service within the Village, including the following: (i) recurring charges for cable service or video service; (ii) event-based charges for cable service or video service, including, but not limited to, pay-per-view and video-on-demand charges; (iii) rental of set-top boxes and other cable service or video service equipment; (iv) service charges related to the provision of cable service or video service, including, but not limited to, activation, installation, and repair charges; (v) administrative charges related to the provision of cable service or video service, including but not limited to service order and service termination charges; and (vi) late payment fees or charges, insufficient funds check charges, and other charges assessed to recover the costs of collecting delinquent payments.

SECTION 4. For purposes of the calculation of service provider fees, "gross revenues" shall not include: (i) revenues not actually received, even if billed, such as bad debt; (ii) the service provider fee or any tax, fee or assessment of general applicability; (iii) any revenues received from services not classified as cable service or video service, including, without limitation, revenue received from telecommunications services, voice over internet protocol (VoIP) services, information services, the provision of directory or Internet advertising, or any other revenues attributed by the holder to noncable service or nonvideo service in accordance with the holder's books and records and records kept in the regular course of business and any applicable laws, rules,

regulations, standards, or orders; (iv) security deposits collected from subscribers, or (v) any amounts paid by subscribers to "home shopping" or similar vendors for merchandise sold through any home shopping channel offered as part of the cable service or video service.

SECTION 5. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate, or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 6. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7. This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form (which publication is hereby authorized) as provided by law.







ORDINANCE NO. 2016-O-

AN ORDINANCE TO AMEND CHAPTER 41, TRAFFIC, SECTION 41.23,  
TOWING AWAY VEHICLES, AS AMENDED,  
OF THE PALESTINE VILLAGE CODE

WHEREAS, the State of Illinois gives municipalities the right to seize vehicles under certain conditions pursuant to the Motor Vehicle Code, being 625 ILCS 5; and

WHEREAS, the Palestine Village Code, being Chapter 41, TRAFFIC, Section 41.23, TOWING AWAY VEHICLES, provides for the towing and impounding of vehicles in certain circumstances; and

WHEREAS, the Board of Trustees of the Village of Palestine, Illinois incurs expenses as a result of the towing and impounding of improperly parked and seized vehicles and storing them until the time for their proper disposition; and

WHEREAS, the Village of Palestine wishes to recoup its expenses related to towing, impounding, and storing vehicles and to deter practices that are detrimental the Village.

WHEREAS, the Board of Trustees has determined to further amend said Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois as follows:

(a) Members of the Police Department are hereby authorized, when reasonably necessary, for the security of the vehicle or to prevent obstruction of traffic, to remove from the streets and impound any vehicles whose operator is arrested, or any unattended vehicle which is parked, so as to constitute an obstruction or hazard to normal traffic.

(b) Any impounded vehicle shall be stored until the owner or other person entitled thereto claims it, gives satisfactory evidence of ownership or right to possession, and pays all applicable fees and costs or until it is otherwise lawfully disposed of.

(c) The fee for impounding a vehicle shall be equal to the fee charged by the wrecker service that tows the vehicle. The storage cost of the impounded vehicle shall be \$25.00 a day for each motor vehicle stored in the impoundment lot. Any part of a day shall count as a whole day.

BE IT FURTHER ORDAINED that if any section, phrase, sentence or portion of this Ordinance is held invalid or unconstitutional for any reason by a court of competent

jurisdiction, such portion shall be deemed a separate, distinct and independent provision; and such holding shall not affect the validity of remaining portions thereof.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
